An Act concerning the State Department of Transportation and adding a new route to the State highway system.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1 1. The Commissioner of Transportation shall, as soon as prac-
- 2 ticable, and in accordance with the procedures set forth in article 1
- 3 of chapter 7, Title 27, of the Revised Statutes, add to the present
- 4 State highway system the following described route: Extending
- 5 from Carll's Corner, generally in an easterly direction to State
- 6 Highway *[47]* *55* in Vineland, New Jersey, and more particu-
- 7 larly known as Landis avenue, partly in Cumberland and partly in
- 8 Salem county, being designated in Cumberland county as roads
- 9 No. 22 and No. 23 and in Salem county as road No. 6.
- 1 2. When this route is taken into the State highway system, as
- 2 provided in section 1 of this act, the Commissioner of Transporta-
- 3 tion shall designate the said route by an appropriate route number
- 4 as provided by law.
- 1 3. This act shall take effect immediately.

This bill directs the Department of Transportation to adopt as a State highway a route extending through parts of Cumberland and Salem counties. Such route is known as Landis Avenue. The committee amended the bill, at the suggestion of the Department of Transportation, so as to extend such route from Corll's Corner, generally in an easterly direction to State Highway 55 in Vineland, New Jersey rather than State Highway 47.

The Department of Transportation supports this bill, as amended, inasmuch as the department's position is to take Landis Avenue on the State lighway system.

This legislation directs the Commissioner of Transportation to add to the present State highway system a specified route extending through parts of Cumberland and Salem counties.

According to the bill's fiscal note, the "enactment of this legislation would require a State expenditure of \$1,320,000.00 in fiscal 1977-78 and \$1,200,000.00 in fiscal 1978-79." If design plans are complete and if the 30% State matching funds are available, this project can be completed during the 1978-79 fiscal year.

The Department of Transportation has indicated its support for this legislation.

The Official Copy Reprint of Assembly Bill No. 345 adds a specified section of county roads in Cumberland and Salem counties to the State highway system.

The Department of Transportation estimates that enactment of this legislation would require a State expenditure of \$1,320,000.00 in fiscal 1977-78 and \$1,200,000.00 in fiscal 1978-79. The department states that if the design plans are complete and State matching funds are available, this project could be completed in fiscal 1978-79. The department anticipates improving this section of roads by using Federal participating funds in a 70-30 matching ratio.

The fiscal note is based on an estimate of costs rather than actual cost information.

In compliance with written request received, there is hereby submitted a fiscal estimate for the above bill, pursuant to P. L. 1962, c. 27.
