#### INTRODUCED MAY 24, 1979

By Senators YATES and MERLINO

Referred to Committee on Institutions, Health and Welfare

An Act concerning children and repealing certain statutes.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. The following sections, acts and parts of acts, together with
- 2 all amendments and supplements thereto, are hereby repealed:
- 3 R. S. 9:5-1 to 9:5-5 inclusive;
- 4 R. S. 9:8-1;
- 5 R. S. 9:9-1 to 9:9-3 inclusive;
- 6 R.S. 9:20-1 to 9:20-5 inclusive.
- 1 2. This act shall take effect immediately.

#### STATEMENT

This bill repeals certain sections of Title 9 of the Revised Statutes. A brief description of the sections being repealed and the reason for their repeal follows:

- 1. R. S. 9:5-1 prohibits the sale of cigarettes or tobacco to minors, and R. S. 9:5-2 imposes a penalty of \$20.00 upon the seller for each sale so made. These sections should be repealed as they have been superseded by N. J. S. 2A:170-51 which provides that any person selling cigarettes or tobacco to a minor is a disorderly person and punishable by a fine of not more than \$100.00.
- 2. R. S. 9:5-3 states that it is unlawful for a minor to play billiards or pool in any saloon or place kept by a person for gain or profit. R. S. 9:5-4 imposes a penalty of \$20.00 upon any person keeping a saloon or place for gain or profit and knowingly allowing a minor to play billiards or pool therein. These sections should be repealed because they were covered by N. J. S. 2A:170-54. That section made violation a disorderly persons offense but was repealed by P. L. 1971, c. 98.
- 3. R. S. 9:5-5 authorizes the courts, constables, sheriffs and police officers to assist agencies in the prevention of cruelty to children.

The courts, and the officers noted, within their respective spheres, are entrusted with the enforcement of all of the laws of this State. The retention of this section is unnecessary, and it should be repealed.

- 4. R. S. 9:8-1 authorizes orphan asylums to act as guardians of orphans or children without mothers and bind the children out to work. This section is obsolete and has been superseded by R. S. 9:2-9 et seq., conferring jurisdiction upon the Superior Court or the Juvenile and Domestic Relations Court to make orders concerning the care, custody and welfare of children. This section should be repealed.
- 5. R. S. 9:9-1 to 9:9-3 authorizes benevolent and fraternal organizations to act as a guardian of a child, prescribes their duties as guardian and placing a child in a foster home. These sections are obsolete and have been superseded by R. S. 9:2-9 et seq., conferring jurisdiction upon the Superior Court or the Juvenile and Domestic Relations Court to make orders concerning the care, custody and welfare of children. These sections should be repealed.
- 6. R. S. 9:20-1 to 9:20-5 provide for the establishment of a Juvenile Delinquency Commission and prescribe its duties. The functions of the commission have been collapsed into the New Jersey State Youth Commission created under P. L. 1961, c. 140 (C. 9:23A-1 et seq.), and the retention of these sections is no longer necessary.

This bill repeals sections of Title 9 of the Revised Statutes which have either been superseded by more recent statutes or are considered unnecessary in light of other enabling legislation. The sections being repealed are the following:

- R. S. 9:5-1
- R. S. 9:5-2
- R. S. 9:5-3
- R. S. 9:5-4
- R. S. 9:5-5
- R. S. 9:8-1
- R. S. 9:9-1 to 9:9-3
- R. S. 9:20-1 to 9:20-5

S-3293, sponsored by Senator Charles B. Yates (D-Burlington), which repeals certain mecessary sections of Title 9 of the Revised Statutes pertaining to children.

The bill repeals the following section of Title 9:

- -- prohibiting the sale of cigarettes or tobacco to minors;
- -- making it unlawful for a minor to play billiards or pool in any saloon or other public profit-making establishment;
- -- authorizing courts, constables, sheriffs and police officers to assist in the prevention of cruelty to children;
- -- authorizing benevolent and fraternal organizations to act as a guardian of a child; and
- -- providing for the establishment of a Juvenile Delinquency Commission.

These sections have been repealed because they are superseded by pursuant statutes.

S-3309, sponsored by Senator John F. Russo (D-Ocean), which provides for the sale of a 4.5 acre parcel of land declared surplus by the Department of Defense located in Woodbridge across Route 1 from the Rahway State Prison.

S-3314, sponsored by Senator Frank J. Dodd (D-Essex), which provides for the sale of an approximately 1.4 acre parcel of land (the Orange Armory) in the City of Orange.

S-3477, sponsored by Senator Eugene J. Bedell (D-Monmouth), which authorizes the exchange of 44.918 acres of State land for a parcel of identical size now owned by the county of Monmouth. This exchange allows both parties to round out existing holdings in the Turkey Swamp area.

A-690, sponsored by Assemblyman Ernest F. Schuck (D-Camden), which exempts agents of mutual benefit associations from the provisions of the unemployment compensation law if the agents are solely paid through commissions.

Currently, mutual fund and securities brokers, insurance agents, real estate agents and door-to-door sales people are exempt from the law.
