

STATE OF NEW JERSEY

INTRODUCED APRIL 12, 1976

By Senators SCARDINO, ORECHIO, GARRAMONE, FAY, DUNN and ZANE

- A SUPPLEMENT to "An act to amend and supplement the 'Local Public Contracts Law,' approved June 9, 1971 (P. L. 1971, c. 198)," approved March 3, 1976 (P. L. 1975, c. 353).
- 1 BE IT ENACTED by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1 1. Notwithstanding the provisions of section 15 of P. L. 1975,
- 2 c. 353, the amendatory and supplementary provisions of the afore-
- 3 said act shall remain inoperative for a period of *[1 year]* *90
- 4 days* after the effective date of this act.
- 1 2. This act shall take effect immediately.

EXPLANATION—Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted in the law.

STATE OF NEW JERSEY

DATED: APRIL 29, 1976

Senate Bill No. 1377 stays and postpones the implementation of the amendments and supplements to the Local Public Contracts Law contained in P. L. 1975, c. 353.

The Senate committee amendment changes the period of postponement to 90 days from the effective date of this act.
