STATEMENT

The purpose of this bill is to allow a municipal appointing authority to appoint to a uniformed firefighting position certain persons who have been civilian members of the fire division of a municipal department of public safety, where the civilian position which was so held by such persons is being discontinued or abolished.

ASSEMBLY BILL NO. 1440 (OCR)

To the General Assembly:

Pursuant to Article V, Section I, paragraph 14(b) of the Constitution, I herewith return Assembly Bill No. 1440 (OCR), with my objections, for reconsideration.

This bill, which represents a response to a problem arising out of a change in form of government in Paterson, would authorize the municipal appointing authority, with the consent of the governing body, to appoint with permanent civil service status to a uniform firefighting position certain linemen and repairmen who have performed in said capacity for a period of eighteen or more years. Because of the length of service of these individuals, certain examination, age, and physical requirements would be waived.

I am convinced that the individuals affected by this bill are deserving of the benefits provided. However, the sponsor has brought to my attention an error which would inadvertently exclude certain deserving individuals from the benefits provided. Moreover, as with State Government, the final selection authority should rest with the appointing authority rather than the governing body.

Accordingly, I herewith return Assembly Bill No. 1440 (OCR) for reconsideration and recommend that it be amended as follows:

Page 1, Section 1, lines 2 & 3: Delete from "with" on line 2 to "and" on line 3.

Page 1, Section 1, line 6: Delete from "fire" on line 6 to
"in" on line 7.

Page 1, Section 1, lines 10, 11 and 12: Delete from "system" to "linemen" and insert "signal system repairman or lineman".

Page 1, Section 1, line 12: After "served" insert "in that capacity".
