A Supplement to "An act concerning counties, and authorizing the board of chosen freeholders of any county to acquire by gift, grant, contribution, devise, bequest or condemnation, lands and interests therein within the county, and to hold, develop, control, maintain and regulate the same for public park, public recreation, public welfare and hospital purposes," approved April 13, 1940 (P. L. 1940, c. 33, C. 40:32–2.1 et seq.), as said title was amended by P. L. 1963, c. 48.

This bill, as amended by the committee, authorizes any county to appoint and establish a county park police system in parks, parkways and recreation areas under its control. The amendments exclude those counties that have adopted the Optional County Charter Law since they already possess these powers and in order that the language used not be interpreted as a limitation upon these counties.

Senate Bill No. 1209 authorizes the creation of a county park constabulary and provides for the organization thereof.

The board of chosen freeholders of any county maintaining any park or recreation area, pursuant to P. L. 1940, c. 33 (C. 40:32-2.1 et seq.), is authorized to establish a constabulary for the purpose of preserving order, protecting public property in and enforcing such rules and regulations as the board may adopt for the park or recreation areas.

Additionally, this bill (1) authorizes the county to organize the constabulary into a police system and provide for appointment thereto and for the control and management thereof, and (2) grants general police powers (of police officers and constables) to such constabulary, including police powers throughout the territorial limits of the county to be exercised while in the performance of their duties.

Governor Brendan Byrne signed a bill Thursday permitting counties which do not have county park commissions to establish park police forces to preserve order in recreation areas under their control.

The bill, <u>S-1209</u> requires that members of the park police forces must complete a police training course at a school approved and authorized by the New Jersey Police Training Commission.

County Park Police forces established under the bill would only have police powers in park areas under their jurisdiction.

The bill was sponsored by Senator John Russo (D-Ocean).
