


INTRODUCED JANUARY 20, 1975

By Senator RUSSO

Referred to Committee on County and Municipal Government

An Acr authorizing certain counties to provide for public transportation services and the operation thereof, and supplementing subtitle 2 of Title 40 of the Revised Statutes.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. The board of chosen freeholders of any county of the fifth
- 2 class may by resolution provide for the establishment of a public
- 3 transportation service and the operation of a public transportation
- 4 system within the county and to the extent that it is agreeable and
- 5 deemed advisable, between the county and municipalities within
- 6 adjoining counties. The board may acquire, erect or lease such
- 7 vehicles, equipment and facilities, including land and buildings, and
- 8 do any and all things necessary for the establishment and operation
- 9 of the public transportation service and system.
- 1 2. Any county operating or providing for the operation of a
- 2 transportation service and system pursuant to this act may contract
- 3 with any public or private entity or corporation for the operation,
- 4 in whole or part, of the service and system for and on behalf of the
- 5 county.
- 1 3. This act shall take effect immediately.

Senate Bill 3012 allows the board of chosen freeholders of any county of the fifth class to establish and operate a public transportation service within the county, and, insofar as it may be agreeable and advisable, in municipalities within adjoining counties. The board may do all things necessary to effectuate the purposes of the bill.

Section 2 of the bill permits any county providing or operating such a transportation system, to contract with any public or private entity or corporation for the operation of said transportation system or service.
