PRE-FILED FOR INTRODUCTION IN THE 1974 SESSION

By Senator MENZA

An Act to amend "An act concerning mortgages on real property," approved June 6, 1968 (P. L. 1968, c. 54).

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1 1. Section 2 of P. L. 1968, c. 54 (C. 46:10b-2) is amended to
- 2 read as follows:
- 3 2. Prepayment of a mortgage loan may be made by or on behalf
- 4 of a mortgagor at any time, and the holder of the mortgage loan
- 5 shall be entitled to charge and collect a fee for the exercise of the
- 6 right of such prepayment according to the following schedule:
- 7 (a) If prepayment is made within the first year from the date
- 8 of such mortgage loan, the prepayment fee shall not exceed 3%
- 9 of the [face amount] balance due on the mortgage loan as of the
- 9A date of prepayment of the mortgage loan;
- 10 (b) If prepayment is made on or after 1 year from the date of
- 11 the mortgage plan, but within 2 years from such date, the prepay-
- 12 ment fee shall not exceed 2% of the [face amount] balance due
- $12 \mbox{\ensuremath{\mathtt{A}}}$ on the mortgage loan as of the date of prepayment of the mort-
- 13 gage loan;
- 14 (c) If prepayment is made on or after 2 years from the date of
- 15 the mortgage loan, but within 3 years from such date, the prepay-
- 16 ment fee shall not exceed 1% of the [face amount] balance due
- 16A on the mortgage loan as of the date of prepayment of the mort-
- 17 gage loan;
- 18 (d) If prepayment is made on or after 3 years from the date of
- 19 the mortgage loan, no fee shall be charged or collected therefor.
- 1 2. This act shall take effect immediately.

This bill amends the law which provides a schedule of fees which a mortgagee may charge a mortgagor for prepayment of a mortgage to provide that the prepayment fee shall be determined upon the balance due as of the date of prepayment instead upon the face amount of the mortgage.
