
INTRODUCED APRIL 7, 1975

Referred to Committee on Agriculture and Environment

An Act providing for a special pheasant and quail stamp for hunters using designated Division of Fish, Game and Shellfisheries wildlife management areas, establishing a fee therefor and supplementing Title 23 of the Revised Statutes.

- Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. No person shall at any time hunt for, pursue, kill, take or
- 2 attempt to take with a firearm or bow and arrow, or have in
- 3 possession, any pheasant or quail while present in such division
- 4 wildlife management areas as may be designated in the Fish and
- 5 Game Code unless such person has first procured in addition to a
- 6 hunting license a valid "special pheasant and quail stamp."
- 7 This special pheasant and quail "stamp" shall be in the
- 8 possession of the hunter at all times while engaged in hunting
- 9 pheasant or quail in such division wildlife management areas as
- 10 may be designated in the Fish and Game Code and the hunter shall
- 11 exhibit the special stamp for inspection to any conservation officer,
- 12 deputy conservation officer or police officer requesting to see the
- 13 stamp.
- 1 2. a. The stamp issued pursuant hereto shall be known as the
- 2 "special pheasant and quail stamp" and shall authorize the holder
- 3 to hunt pheasant and quail during seasons prescribed in the State
- 4 Fish and Game Code in such wildlife management areas as may be
- 5 designated in the Fish and Game Code.
- 6 b. The stamp shall be procured from the Division of Fish, Game
- 7 and Shellfisheries at Trenton or from such agents as may be
- 8 designated by the division. No stamp shall be valid unless it
- 9 contains the signature of the owner. The division shall determine

- 1 3. The fee for this stamp shall be \$5.00. The amounts remitted

- 3 be deposited to the credit of the "hunters' and anglers' license

- 4. A person who at any time alters, loans, or transfers to another
- 2 a "special pheasant and quail stamp," or who hunts for, pursues,
- 3 kills, takes or attempts to take with a firearm or bow or arrow, or
- 4 has in possession, a pheasant or quail in such wildlife management
- 5 areas as may be designated in the Fish and Game Code without a
- 6 proper and valid special pheasant and quail stamp, or violating any
- 7 other provisions of this act shall be liable to a penalty of not less
- 8 than \$25.00 nor more than \$50.00 for each offense.
- 1 5. This act shall take effect immediately.

STATEMENT

The purpose of this bill is to establish a special fee to help defray costs for the hunting of pheasants and quail that are artificially propagated and stocked by the division in selected Division of Fish, Game and Shellfisheries controlled wildlife management areas.

The anticipated increase in division revenue from sale of these special stamps would be approximately \$150,000.00.



This bill is part of the proposed new funding program of the Division of Fish, Game and Shellfisheries and would require the purchase of a special pheasant and quail stamp by hunters using wildlife management areas where artificially propagated pheasant and quail are stocked by the division. The anticipated annual revenue, which would be used to defray the costs of such propagation and stocking, is expected to be approximately \$150,000.00.

Assembly Bill No. 3207 establishes a fee for a special pheasant and quail stamp for hunters using designated management areas.

The Division of Budget and Accounting estimates that enactment of this legislation would increase State revenues by \$124,000.00 in fiscal 1975-76 and by \$127,550.00 in fiscal 1976-77.

The fiscal note is based on an estimate of costs rather than actual cost information.
