STATE OF NEW JERSEY

INTRODUCED DECEMBER 10, 1974

By Senators FELDMAN, GARRAMONE and SCARDINO

(Without Reference)

- A SUPPLEMENT to the "New Jersey American Revolution Bicentennial Celebration Act," approved March 2, 1973 (P. L. 1973, c. 48).
- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. The New Jersey Bicentennial Celebration Commission is au-
- 2 thorized to designate a design or mark as the official New Jersey
- 3 American Revolution Bicentennial Celebration Emblem. The com-
- 4 mission may file for public informational purposes, a true copy
- 5 of said emblem with the Secretary of State and cause a true copy
- 6 thereof to be published in the New Jersey Register, provided,
- 7 however, such filing and publication shall not be a prerequisite or
- 8 condition precedent to the effectiveness and enforceability of any
- 9 provision of this act.
- 1 2. The New Jersey Bicentennial Celebration Commission may
- 2 approve the use by a person of the New Jersey American Revolu-
- 3 tion Bicentennial Celebration Emblem upon such terms and con-
- 4 ditions respecting the use of said emblem as it deems in the public
- 5 interest, including the payment of monetary consideration to the
- 6 New Jersey Bicentennial Celebration Commission. The provisions
- 7 of any other law to the contrary notwithstanding, the commission
- 8 shall not be required to solicit or obtain public bids in connection
- 9 with the granting of approval to use the said emblem.
- 3. a. Any person who makes unauthorized use of the New Jersey
- 2 American Revolution Bicentennial Celebration Emblem shall be
- 3 liable to a penalty of not less than \$250.00 nor more than \$1,000.00
- 4 to be collected in a civil action by a summary proceeding under the
- 5 Penalty Enforcement Law (N. J. S. A. 2A:58-1 et seq.). If the
- 6 violation is of a continuing nature, each day during which it
- 7 continues shall constitute an additional, separate and distinct

- 8 violation. The Superior Court, County Court, county district court,
- 9 and municipal court shall have jurisdiction over the matter of an
- 10 alleged violation of this act.
- b. In addition to such other relief as is provided herein, the New
- 12 Jersey Bicentennial Celebration Commission shall, be entitled to
- 13 institute a civil action against any person who shall have violated
- 14 section 1 of this act and to secure injunctive relief in such action
- 15 prohibiting the further unauthorized use of the emblem. The
- 16 Superior Court shall have jurisdiction over such an action and
- 17 the said court may proceed in the action in a summary manner.
- 18 Such action may include a demand for penalties as provided for
- 19 in subsection a hereof. For the purposes of this act, unless the
- 20 context clearly requires a different meaning:
- 21 "Person" means and shall include corporations, companies,
- 22 associations, societies, firms, partnerships, and joint stock com-
- 23 panies as well as individuals, and shall also include all political
- 24 subdivisions of this State or any agencies or instrumentalities
- 25 thereof.

- 26 "Unauthorized use" means and shall include any use, exhibit,
- 27 display, publication, reproduction, or dissemination of the emblem
- 28 without the written approval of the New Jersey Bicentennial Cele-
- 29 bration Commission.
 - 4. This act shall take effect immediately.

STATEMENT

This bill supplements the "New Jersey American Revolution Bicentennial Celebration Act" to authorize the commission to designate and regulate the use of an official emblem and provide penalties for the unauthorized use of the emblem.
