# STATE OF NEW JERSEY

#### INTRODUCED DECEMBER 3, 1974

#### (Without Reference)

An Act concerning the Passaic valley sewerage district and the Passaic Valley Sewerage Commissioners, and amending R. S. 58:14-3.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1 1. R. S. 58:14-3 is amended to read as follows:
- 2 58:14-3. The board shall consist of [five] seven members who
- 3 are residents of the district, not more than four of whom shall be
- 4 of the same political party. Upon the expiration of the term of
- 5 office of a commissioner, his successor shall be appointed by the
- 6 Governor, by and with the advice and consent of the Senate, for
- 7 a term of 5 years. The Governor may remove any commissioner
- 8 from office for cause.
- 9 Each commissioner shall hold his office until his successor has
- 10 been appointed, and any vacancy in the membership of the com-
- 11 mission because of death, resignation or removal, shall be filled for
- 12 the unexpired term in the manner provided for on original appoint-
- 13 ment. In making any appointment hereunder, either for a full term
- 14 or to fill a vacancy, regard shall be had to ability and fitness, and
- 15 also locality, so that each section of the district may be represented
- 16 as far as practicable with at least one member from each county
- 17 within the district, but not more than two members from the same
- 18 county.
- 1 2. This act shall take effect immediately.

#### STATEMENT

The purpose of this bill is to increase the membership of the Passaic Valley Sewerage Commission to seven members and to provide that at least one member shall be from each county within the district but not more than two shall be from the same county.
