

An Act concerning certain counties in relation to certain road supervisors and supplementing chapter 14 of Title 27 of the Revised Statutes.

1 BE IT ENACTED by the Senate and General Assembly of the State 2 of New Jersey:

1. The board of chosen freeholders of any county having a 1 population of \*[more than 500,000]\* \*between 500,000 and 550,000,  $\mathbf{2}$ according to the 1970 census,\* may, by resolution, provide that 3 the county road supervisor of such county shall continue to be the 4 county road supervisor of such county during good behavior, and 5 that he shall not be removed as such county road supervisor except 6 for cause on notice and after a hearing before said board of chosen 7 freeholders; provided that said county road supervisor is a dis-8 abled veteran who has continuously served as county road super-9 visor of the respective county for a period of 3 years. 10 1 2. This act shall take effect immediately.

EXPLANATION—Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted in the law.



- An Act concerning certain counties in relation to certain road supervisors and supplementing chapter 14 of Title 27 of the Revised Statutes.
- 1 BE IT ENACTED by the Senate and General Assembly of the State 2 of New Jersey:
- 1 1. The board of chosen freeholders of any county having a 2 population of more than 500,000 may, by resolution, provide that 3 the county road supervisor of such county shall continue to be the 4 county road supervisor of such county during good behavior, and 5 that he shall not be removed as such county road supervisor except 6 for cause on notice and after a hearing before said board of chosen 7 freeholders; provided that said county road supervisor is a dis-8 abled veteran who has continuously served as county road super-9 visor of the respective county for a period of 3 years.
- 1 2. This act shall take effect immediately.

## STATEMENT

This bill authorizes counties having a population of more than 500,000 inhabitants to grant tenure to any county road supervisor who is a disabled veteran and who has served as county road supervisor of the respective county for a period of 3 years.

DATED: APRIL 21, 1975

As amended, this bill authorizes counties having a population of between 500,000 and 550,000 according to the 1970 census to grant tenure to any county road supervisor who is a disabled veteran and who has served as county road supervisor for 3 years. The committee's amendment reflects its effort to ensure that the bill will affect only the situation in which it is needed.
