As reported by the committee, Assembly Bill No. 4865 permits detectives in the Division of State Police in the Department of Law and Public Safety to administer oaths when investigating a violation or attempted violation of a criminal law.

Under current law, investigators in the Division of Criminal Justice in the Department of Law and Public Safety, as well as both detectives and investigators in the County Prosecutors' Offices, are authorized to administer oaths in relation to a matter involving a violation or attempted violation of a criminal law. The bill extends this same authority to administer oaths to detectives in the Division of State Police in the Department of Law and Public Safety.

Current law confers this same authority to administer oaths on investigators in the Division of Criminal Justice in the Department of Law and Public Safety and on both detectives and investigators in the County Prosecutors' Offices in relation to a matter involving a violation or attempted violation of a criminal law. The bill extends this same authority to administer oaths to detectives in the Division of State Police in the Department of Law and Public Safety.

During the course of criminal investigations, it is necessary for State police detectives to question witnesses and take sworn statements. They currently do not have the statutory authority to administer the oath in taking these statements, and therefore they rely on investigators in the county prosecutor's office or the Division of Criminal Justice to do so. This bill will streamline the investigative process.

As reported by the committee, Assembly Bill No. 4865 is identical to Senate Bill No. 3230, which also was reported by the committee on this same date.

During the course of criminal investigations, it is necessary for State police detectives to question witnesses and take sworn statements. They currently do not have the statutory authority to administer the oath in taking these statements, and therefore they rely on investigators in the county prosecutor's office or the Division of Criminal Justice to do so. This bill will streamline the investigative process.

As reported by the committee, Senate Bill No. 3230 is identical to Assembly Bill No. 4865, which also was reported by the committee on this same date.
