The bill applies to professional and occupational boards, agencies, and committees that are located in the Division of Consumer Affairs in the Department of Law and Public Safety or in the DEP.

The OLS anticipates that this bill may cause an indeterminate annual State expenditure increase. The Division of Consumer Affairs in the Department of Law and Public Safety; the DEP; and all their professional and occupational boards, agencies, and committees that administer licensing examinations will experience a workload increase as a result of collecting and reporting licensure examination passage and failure rates for professions and occupations under their supervision and summarizing and reporting those findings to the Legislature. The magnitude of any related expenditure increase will depend on operational decisions to be made by affected agencies, which the OLS cannot anticipate. Any cost increase would likely be negligible.

The State's "Licensed Occupations" database provides an alphabetical list of occupations that require a license in New Jersey. This database lists 23 licenses issued by the DEP, and 81 licenses issued by the division. The division's website states that it maintains 46 professional and occupational licensing boards that oversee and regulate more than 750,000 individuals and businesses in New Jersey. It is not known how many of these boards require licensing examinations.
