The Assembly Appropriations Committee reports favorably Assembly Bill No. 1257, with committee amendments.

As amended, this bill requires school buses that provide transportation for students using wheelchairs to have an aide to assist the students and be equipped with a four-point securement system for each student using a wheelchair on the school bus, beginning on September 1 of the second year next following the year of enactment of the bill. A four-point securement system is defined by the bill as a complete four-point system that includes four wheelchair restraints to secure a wheelchair to the vehicle floor; a lap and shoulder belt that integrates to the rear wheelchair restraints; and floor anchorages installed in the vehicle floor. The bill requires that students using wheelchairs be secured using the four-point securement system at all times while the bus is in operation, and that the school bus operator or aide secure or cause to be secured a passenger using a wheelchair using the properly adjusted and fastened four-point securement system.

FISCAL IMPACT:

The Office of Legislative Service (OLS) estimates that Assembly Bill No.1257 (1R) will increase school districts' expenditures by approximately \$17.6 million. The bill's requirement that a bus be equipped with a four-point securement system if it is used to transport passengers who use a wheelchair will not lead to an expenditure increase, as this requirement mirrors current federal regulations.

To estimate the number of additional school bus aides that would be required under the bill, the OLS, based on data from the Census Bureau's American Community Survey and the Survey of Income and Program Participation, estimated that there are approximately 1,800 children between the ages of five and 17 who use a wheelchair. According to data from the Bureau of Labor Statistics, the median hourly wage for transportation attendants in New Jersey is \$12.51. In addition to the hourly wage, the school district would be responsible for the employer's share of FICA taxes (7.65 percent of the wages). The estimate assumes that the aides are employed for four hours per day and 180 days per year. The estimate further assumes each student who uses a wheelchair travels on a different bus and, therefore, would each require an aide. The actual expenditure increase would be lower if: 1) multiple students who use a wheelchair travel on the same school bus; and 2) if some of the students, as part of their individualized education plans, already have an aide on the school bus.

COMMITTEE AMENDMENTS:

The amendments add the requirement that beginning on September 1 of the second year next following the year of enactment of the bill, a school bus that provides transportation for passengers using wheelchairs must have an aide to assist the passengers, and that a school bus operator or aide must secure or cause to be secured a passenger using a wheelchair using the properly adjusted and fastened four-point securement system. The amendments also revise the synopsis accordingly.

The Senate Budget and Appropriations Committee reports favorably Assembly Bill No. 1257 (2R).

A four-point securement system is defined by the bill as a complete four-point system that includes four wheelchair restraints to secure a wheelchair to the vehicle floor; a lap and shoulder belt that integrates to the rear wheelchair restraints; and floor anchorages installed in the vehicle floor. Under the bill, students using wheelchairs are required to be secured using the four-point securement system at all times while the bus is in operation.

The bill takes effect immediately upon enactment, but remains inoperative until the September 1 of the second year next following enactment.

As reported, this bill is identical to Senate Bill No. 2638, as also reported by the committee.

FISCAL IMPACT:

The Office of Legislative Services estimates that the bill's requirement that school buses, if used to transport students who use a wheelchair, be equipped with a four-point securement system will not increase school districts' expenditures. This requirement mirrors federal requirements for school bus passenger seating and restraining barriers under current federal regulations at 49 C.F.R. s.571.222.

• The Office of Legislative Services (OLS) anticipates that Assembly Bill No. 1257 of 2016 will not have a fiscal impact on school districts. The bill requires that, in the case of a school bus that is transporting a student who uses a wheelchair, the bus must be equipped with a four-point securement system for each passenger who uses a wheelchair, and that the school bus operator use the system to secure a passenger who uses a wheelchair. The OLS notes that the four-point securement system required under the bill mirrors existing requirements under federal regulations. As such, the bill would not impose additional costs on school districts.

BILL DESCRIPTION

Assembly Bill No. 1257 of 2016 requires that a school bus that transports passengers who use a wheelchair must be equipped with an appropriate four-point securement system for each passenger who uses a wheelchair. The bill defines such a system as one that includes: 1) four wheelchair restraints to secure a wheelchair to the vehicle floor; 2) a lap and shoulder belt that integrates to the rear wheelchair restraints; and floor anchorages installed on the vehicle floor. The bill also requires that a school bus operator use the securement system to properly secure each passenger who uses a wheelchair.

OFFICE OF LEGISLATIVE SERVICES

The OLS anticipates that Assembly Bill No. 1257 of 2016 will not have a fiscal impact on school districts. Under current federal regulations at 49 C.F.R. s.571.222, each school bus that has one or more locations designed to carry a passenger who uses a wheelchair must have at each such location: 1) no less than four wheelchair securement anchorages; 2) a wheelchair securement device for each anchorage; and 3) wheelchair occupant pelvic and upper torso restraints that comply with federal regulations for safety belt systems. To the extent that the bill's requirements are consistent with current federal regulations, the legislation will not lead to an increase in school districts' expenditures.

- The Office of Legislative Services (OLS) estimates that Assembly Bill No. 1257 (1R) of 2016 will increase school districts' expenditures by \$17.6 million in the first year of implementation, and anticipates that the cost would increase by two percent annually. The projected cost increase is due to the bill's requirement that a school bus that provides transportation to students who use a wheelchair must have an aide.
- The actual cost may be lower than this estimate if: 1) multiple students who use wheelchairs are transported on the same bus, thereby decreasing the number of aides that would be needed; or 2) some students who use a wheelchair already have an aide on the bus under the provisions of the students individualized education plan.
- The bill's requirement that school buses be equipped with a four-point securement system if the bus is used to transport students who use a wheelchair will not increase school districts' expenditures, as this requirement mirrors current federal regulations.

BILL DESCRIPTION

Assembly Bill No. 1257 (1R) of 2016 requires that a school bus that transports passengers who use a wheelchair be equipped with an appropriate four-point securement system for each



passenger who uses a wheelchair. The bill defines such a system as one that includes: 1) four wheelchair restraints to secure a wheelchair to the vehicle floor; 2) a lap and shoulder belt that integrates to the rear wheelchair restraints; and 3) floor anchorages installed on the vehicle floor. The bill also requires that a school bus that transports passengers who use a wheelchair have an aide to assist the passengers, and that the aide or the school bus operator use the securement system to properly secure each passenger who uses a wheelchair.

FISCAL ANALYSIS

EXECUTIVE BRANCH

OFFICE OF LEGISLATIVE SERVICES

The OLS estimates that Assembly Bill No. 1257 (1R) of 2016 will lead to an expenditure increase of approximately \$17.6 million in the first year of implementation, with the cost increasing by two percent annually in subsequent years. The OLS notes that the bill's requirement that a school bus, if it transports passengers who use a wheelchair, be equipped with a four-point securement system would not increase school districts' expenditures, as this requirement mirrors current federal regulations at 49 C.F.R. s.571.222.

The OLS used multiple data sources to estimate the number of students who use a wheelchair. First, according to the 2015 American Community Survey, 7,026 New Jersey residents between the ages of five and 17 reported having ambulatory difficulty (defined as having serious difficulty walking or climbing stairs). In an earlier version of the same survey, 43.9 percent of respondents who indicated that they had such difficulty reported using an ambulatory aid. If one applies this rate to the 2015 survey respondents, approximately 3,084 would use an ambulatory aide. An additional report published by the Census Bureau¹ stated that, nationally, 67,000 children between the ages of six and 14 used a wheelchair or similar device, while an additional 47,000 used a cane, crutches, or walker. This implies that of the individuals in this age range that use an ambulatory aid, 58.8 percent use a wheelchair. When that rate is applied to the estimated 3,084 New Jersey school children who use an ambulatory aide, the OLS estimates that 1,813 children use a wheelchair.

According to the Bureau of Labor Statistics, the median hourly wage for "transportation attendants" in New Jersey is \$12.51. If one assumes that: 1) this is the hourly wage that would be paid to these aides; 2) the aides are employed for four hours per days, and 180 days per year; and 3) students who use a wheelchair are not transported on the same bus, then the estimated additional cost in the first year would be \$17.6 million when one accounts for the additional wages and the employer's share of the FICA tax. The OLS anticipates that the cost will increase at approximately the rate of inflation in subsequent years. The actual cost incurred by school districts may be less than the amount estimated here if: 1) there are situations in which more than one student who uses a wheelchair is transported on the same bus, thereby decreasing the number of aides needed; or 2) some of the students already have an aide on the school bus as part of the student's individualized education plan.

STATEMENT

This bill requires school buses that provide transportation for 11 students using wheelchairs to be equipped with a four-point 12 13 securement system for each student using a wheelchair on the school 14 bus. A four-point securement system is defined as a complete four-15 point system that includes four wheelchair restraints to secure a 16 wheelchair to the vehicle floor; a lap and shoulder belt that integrates to the rear wheelchair restraints; and floor anchorages installed in the 17 18 vehicle floor. Under the bill, students using wheelchairs are required to 19 be secured using the four-point securement system at all times while 20 the bus is in operation.

The Senate Education Committee favorably reports Senate Bill No. 2638.

This bill requires school buses that provide transportation for students using wheelchairs to be equipped with a four-point securement system for each student using a wheelchair on the school bus. A four-point securement system is defined as a complete fourpoint system that includes four wheelchair restraints to secure a wheelchair to the vehicle floor; a lap and shoulder belt that integrates to the rear wheelchair restraints; and floor anchorages installed in the vehicle floor. Under the bill, students using wheelchairs are required to be secured using the four-point securement system at all times while the bus is in operation.

The Senate Budget and Appropriations Committee reports favorably Senate Bill No. 2638.

This bill requires school buses that provide transportation for students using wheelchairs to be equipped with a four-point securement system for each student using a wheelchair on the school bus. A four-point securement system is defined by the bill as a complete four-point system that includes four wheelchair restraints to secure a wheelchair to the vehicle floor; a lap and shoulder belt that integrates to the rear wheelchair restraints; and floor anchorages installed in the vehicle floor. Under the bill, students using wheelchairs are required to be secured using the four-point securement system at all times while the bus is in operation.

The bill takes effect immediately upon enactment, but remains inoperative until the September 1 of the second year next following enactment.

As reported, this bill is identical to Assembly Bill No. 1257 (2R), as also reported by the committee.

FISCAL IMPACT:

The Office of Legislative Services estimates that the bill's requirement that school buses, if used to transport students who a wheelchair, be equipped with a four-point securement system will not increase school districts' expenditures. This requirement mirrors federal requirements for school bus passenger seating and restraining barriers under current federal regulations at 49 C.F.R. s.571.222.
