- 6 payments made for health benefits provided by any county bridge
- 7 commission, established pursuant to article 2 of chapter 19 of Title

ASSEMBLY BILL NO. 1113

To the General Assembly:

Pursuant to Article V, Section I, Paragraph 14(a) of the Constitution, I herewith return Assembly Bill No. 1113, without my approval for the following reasons:

Assembly Bill No. 1113 would amend that section of the Public and School Employees' Health Benefits Act which limits the additional coverage provided by the Act to only those persons who retired on or after July 1, 1964. The proposed amendment would permit any county bridge commission which controls bridges extending into another state to pay the additional coverage to employees who retired prior to July 1, 1964, and would validate any such payment made to date.

I would be opposed to this measure on the basis that it creates a unreasonable exception to the application and effective date of the amended Public and School Employees Health Benefits Act. Beyond this, however, the amendment is unnecessary as no such County Bridge Commission participating in the program evidences the difficulty which this bill is designed to resolve.
