An Act to amend the title of "An act to authorize any municipality to waive, release or modify any covenants, conditions or limitations as to the erection of buildings or any other use to be made of land imposed in sales and conveyances of lands by said municipality, and supplementing article 2 of chapter 60 of Title 40 of the Revised Statutes," approved March 27, 1943 (P. L. 1943, c. 33), as said Title was amended by P. L. 1946, chapter 140, so that the same shall read "An act to authorize any municipality to waive, release, modify or subordinate any terms, covenants, conditions, limitations or reverters imposed in sales and conveyances of lands as to the erection, alteration or demolition of buildings or any other use to be made of land imposed by said municipality, and supplementing article 2 of chapter 60 of Title 40 of the Revised Statutes," and to amend the body of said act.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. The title of P. L. 1943, chapter 33, as said title was amended
- 2 by P. L. 1946, chapter 140, is further amended to read as follows:

- subordinate any terms, covenants, conditions For 1. limitations or reverters imposed in sales and conveyances of lands as to the erection, alteration or demolition of buildings or any other use to be made of land heretofore imposed by said municipality [in sales and 9 conveyances of land by such municipality to accomplish the purposes for which such lands were sold and conveyed either at public 10 or private sale made prior to January 1, 1969, but only after public 12 hearing held before such governing body, of the holding of which 13 notice describing the lands in question, and the terms, covenants, 14 conditions [or], limitations or reverters to be waived, released [or], modified or subordinated, and, if to be modified or subordinated, 15 describing the manner in which the same shall be modified or sub-16 17 ordinated, shall first have been given by advertisement published 18 once each week for 2 weeks in a newspaper published in said municipality or, if no newspaper be published therein, then in a news-19 paper circulating in such municipality, provided, however, that the 20 21power herein granted shall not be exercised to impair any vested 22or contractual rights of third parties.
- 1 3. This act shall take effect immediately.
