A SUPPLEMENT to "An act continuing the Department of Banking and Insurance as a principal department in the Executive Branch of State Government to be known and designated as the Department of Banking," approved February 16, 1970 (P. L. 1970, c. 11, C. 17:1B-1 et seq.).

1 BE IT ENACTED *by the Senate and General Assembly of the State*
2 *of New Jersey:*

1 1. Notwithstanding the provisions of any other law, the com-
2 missioner shall organize the work of the department in such
3 divisions, not inconsistent with the provisions of this act, and in
4 such bureaus and other organizational units as he may determine
5 to be necessary for efficient and effective operation.

1 2. This act shall take effect immediately.

1 2. This act shall take effect immediately.
