## STATE OF NEW JERSEY

## INTRODUCED APRIL 30, 1970

By Senators SEARS, BATEMAN, KNOWLTON, DICKINSON and MARAZITI

## (Without Reference)

An Act establishing and concerning a Division of Data Processing and Telecommunications in the Department of the Treasury and providing the appropriation therefor.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. There is hereby established in the Department of the Treasury
- 2 the Division of Data Processing and Telecommunications. The divi-
- 3 sion shall be under the immediate supervision of a director who shall
- 4 be appointed by and serve at the pleasure of the State Treasurer
- 5 and who shall administer the work of the division under the direc-
- 6 tion and supervision of the State Treasurer. The State Treasurer
- 7 shall fix the compensation of the director within the limits of avail-
- 8 able appropriations.
- 1 2. The State Treasurer shall establish within the division two
- 2 bureaus, to be designated the bureau of data processing and the
- 3 bureau of telecommunications management. The State Treasurer
- 4 shall organize the work of the division in such other bureaus and
- 5 other organizational units as he may determine to be necessary for
- 6 efficient and effective operation and shall assign to the division
- 7 such employees in the Department of the Treasury as may be nec-
- 8 essary to assist the director in the performance of his duties.
- 1 3. The division shall:
- 2 (a) Assure the effectiveness of information processing through-
- 3 out the State Government.
- 4 (b) Advise in policy and planning decisions to insure that the
- 5 State Government is responsive to new programs involving data
- 6 handling responsibilities.
- 7 (c) Assure that the information processing capabilities of the
- 8 State are kept current and abreast of changing technology.

EXPLANATION—Matter enclosed in bold-faced brackets Ithus I in the above bill is not enacted and is intended to be omitted in the law.

- 9 (d) Be the organization through which the agencies of the State
- 10 Government are kept informed as to current Statewide informa-
- 11 tion processing capabilities and informed as to available machine
- 12 sensible information.
- 13 (e) Be responsible for the continued development of efficient
- 14 uses of information processing.
- 15 (f) Assure that telecommunication services are provided
- 16 throughout the State Government in the most economical, uniform
- 17 and effective manner.
- 4. In order to accomplish the foregoing, the division shall:
- 2 (a) Be responsible for evaluating all requests affecting the in-
- 3 formation processing facilities of the State including:
  - (1) The acquisition, continuation or alteration of equipment.
  - (2) The use of consulting firms in information processing
- 6 studies or projects.

- (3) The purchase of information processing services.
- 8 (b) Direct the assignment and reassignment of information
- 9 processing tasks among the various State Government information
- 10 processing facilities.
- 11 (c) Be the organization to represent the State in all intergovern-
- 12 mental matters relating to information processing.
- 13 (d) Promulgate such rules and regulations as shall be necessary
- 14 to effectuate the purposes of this act.
- 5. The bureau of data processing shall:
- 2 (a) Foster and direct the establishment and consolidation of
  - information processing centers throughout the State in order to
- 4 achieve economies in the use of information processing facilities.
- 5 (b) Develop, promulgate and maintain a Statewide master plan
- 6 for the economic and effective use of information processing facili-
- 7 ties.
- 8 (c) Direct and conduct periodic effectiveness audits of the
- 9 various facilities comprising the State's information processing
- 10 capability.
- 11 (d) Determine whether State agencies are prepared to make
- 12 effective use of consultants prior to such consultants being solicited
- 13 or engaged to alter, improve or establish methods or procedures
- 14 involving information processing.
- 15 (e) Monitor the progress of such consultants in order to assure
- 16 that their recommendations and performance are consistent with
- 17 Statewide objectives of efficiency and economy.
- 18 (f) Review requests for the use of commercial service organiza-
- 19 tions and direct the accomplishment of the required tasks by State
- 20 facilities wherever deemed advisable.

- 21 (g) Be responsible, with the using agency, for selection and ac-
- 22 quisition decisions taking into account the necessity for encourag-
- 23 ing competition through solicitation of proposals from qualified
- 24 vendors.
- 25 (h) Determine the advisability of the acquisition and use of
- 26 specific software packages.
  - 1 6. As used in this act, "telecommunications" shall mean any
- 2 transmission, emission or reception of signs, signals, writings,
- 3 images and sounds or intelligences of any nature by wire, radio,
- 4 optical or other electromagnetic system.
- 7. The office of telecommunications management in the Division
- 2 of Purchase and Property established by Executive Order No. 54
- 3 of the Governor, dated May 21, 1969, together with all of its func-
- 4 tions, powers and duties, is transferred to and constituted the
- 5 bureau of telecommunications management in the Division of Data
- 6 Processing and Telecommunications. Such bureau shall continue
- 7 to have all of the powers and shall exercise all of the functions
- 8 and duties vested in it or imposed upon it by said executive order
- 9 or by this or any other law.
- 1 8. The bureau of telecommunications management shall:
- 2 (a) Direct the consolidation and coordination of the State's
- 3 telecommunications facilities in order to insure the efficient and
- 4 economical use of telecommunications services by State agencies.
- 5 (b) Develop technical plans for and recommend communication
- 6 facilities and equipment which will satisfy agency operational
- 7 communications requirements.
- 8 (c) Conduct continuing reviews and evaluations of communica-
- 9 tion facilities and equipment used by State agencies in order to
- 10 insure that agency needs are being fulfilled at the most economical
- 11 cost to the State.
- 12 (d) Develop and implement policies, standards, practices and
- 13 procedures to insure orderly development of State communication
- 14 facilities in an economic and efficient manner.
- 1 \*9. Nothing in this act shall affect the responsibilities of the
- 2 New Jersey Broadcasting Authority, or of the Division of State
- 3 Police with respect to communication facilities, as such responsi-
- 4 bilities are defined by any law of this State.\*
- 1 \*[9.]\* \*10.\* All appropriations and other moneys available and
- 2 to become available to any division, office or other agency, the func-
- 3 tions, powers and duties of which have been herein assigned or
- 4 transferred to the Division of Data Processing and Telecommuni-
- 5 cations, are hereby transferred to the Division of Data Processing
- 6 and Telecommunications established hereunder, and shall be avail-

- 9 imposed by State or Federal laws.
- 1 \*[10.]\* \*11.\* Nothing in this act shall be construed to deprive
- 2 any person of any tenure rights or of any right or protection pro-
- 3 vided him by Title 11 of the Revised Statutes, Civil Service, or
- 4 under any pension law or retirement system.
- 1 \*[11.]\* \*12.\* All files, books, papers, records, equipment and
- 2 other property of any division, office or other agency, the functions,
- 3 powers and duties of which have been herein assigned or trans-
- 4 ferred to the Division of Data Processing and Telecommunications,
- 5 shall upon the effective date of this act be transferred to the Divi-
- 6 sion of Data Processing and Telecommunications.

- 2 tions heretofore made or promulgated by any division, office or

- 6 able to the Division of Data Processing and Telecommunications,
- 7 the expenditure of funds for payment of salaries and expenses
- 8 incident thereto.
- 1 \*[16.]\* \*17.\* This act shall take effect immediately.
