AN ACT concerning education and amending N. J. S. 18A:6-45,  
18A:6-46, 18A:6-47, 18A:6-48 and 18A:6-50.

1 BE IT ENACTED *by the Senate and General Assembly of the State*  
2 *of New Jersey:*

1 1. N. J. S. 18A:6-45 is amended to read as follows:

2 18A:6-45. There is established a body corporate and politic, with  
3 corporate succession, to be known as the ["State federation of  
4 district boards of education."] "*New Jersey School Boards As-*  
5 *sociation.*" All boards of education of the various school districts  
6 in this State shall be members of the ["State federation"] *associa-*  
7 *tion.*

1 2. N. J. S. 18A:6-46 is amended to read as follows:

2 18A:6-46. Each of the district boards of education shall select  
3 annually one of its members as a delegate to the ["State federa-  
4 *tion"] association.*

1 3. N. J. S. 18A:6-47 is amended to read as follows:

2 18A:6-47. The ["State federation"] *association* may investigate  
3 such subjects relating to education in its various branches as it  
4 may think proper, and it shall encourage and aid all movements  
5 for the improvement of the educational affairs of this State.

1 4. N. J. S. 18A:6-48 is amended to read as follows:

2 18A:6-48. The ["State federation"] *association* may select such  
3 officers as may be necessary for the transaction of its business.

1 5. N. J. S. 18A:6-50 is amended to read as follows:

2 18A:6-50. For the purpose of defraying the necessary expenses  
3 of the ["State federation"] *association*, the various district boards  
4 shall pay the necessary expenses incurred by its delegates, and  
5 shall appropriate annually such sums for dues as may be assessed  
6 by the ["federation"] *association* at any delegates meeting, which

EXPLANATION—Matter enclosed in bold-faced brackets [thus] in the above bill  
is not enacted and is intended to be omitted in the law.

7 assessment of dues shall be made only upon  $\frac{2}{3}$  vote of the dele-  
8 gates present at such delegates meeting, after notice of the taking  
9 of such vote shall have been given to each district board in writing  
10 at least 60 days before such delegates meeting. The aforesaid dues  
11 shall be assessed upon a graduated scale according to the size of  
12 the school district, but in no case shall the dues for any one dis-  
13 trict exceed the sum of \$1,500.00 for any 1 year. Dues shall be  
14 payable by the custodian of school moneys of the school district  
15 to the treasurer of the [State federation] association.

1 6. This act shall take effect immediately.

#### STATEMENT

The purpose of this bill is to change the name of the State Federation of District Boards of Education to the New Jersey School Boards Association in order to conform with the names generally given to similar organizations in other states and to indicate the affiliation of the New Jersey organization with the National School Boards Association.
