1 BE IT ENACTED *by the Senate and General Assembly of the State*
2 *of New Jersey:*

1 1. Section 4 of P. L. 1970, chapter 6 (C. 2A:158-15.2) is amended
2 to read as follows:

3 4. Notwithstanding the provisions of N. J. S. 2A:158-16 as-
4 sistant prosecutors required to devote their entire time to the duties
5 of their office shall receive annual salaries, to be fixed by the board
6 of chosen freeholders on recommendation of the county prosecutor,
7 as follows:

8 a. The first assistant prosecutor or the assistant prosecutor
9 serving as the county prosecutor's principal assistant, not less than
10 **[50%]** 60% nor more than 90% of the amount of the annual salary
11 of the county prosecutor; and

12 b. Other assistant prosecutors, not less than **[40%]** 35% nor
13 more than 80% of the amount of the annual salary of the county
14 prosecutor.

1 2. This act shall take effect immediately.
