1 BE IT ENACTED by the Senate and General Assembly of the State 2 of New Jersey:

1 *1. Section 4 of P. L. 1969, chapter 134 (C. 27:1A-28.4) is 2 amended to read as follows:

4. If any public agency or authority shall assume responsibility for operation of motor bus services in order to avoid the loss of such services, [during the first year of operations of service] the department may enter into a contract with said public agency or authority in the same manner and to the same extent as provided in section 1 hereof.*

[1.] *2.* Section 8 of P. L. 1969, chapter 134 is amended to read
as follows:

8. This act shall take effect immediately but shall terminate on July 1, [1970] 1971.

1 *[2.]**3.* There is hereby appropriated from the General Treas-2 ury to the Department of Transportation the sum of \$500,000.00 to 3 carry out the purposes of this act for the period July 1, 1970 to 4 July 1, 1971.

1 *[3.]* *4.* This act shall take effect immediately.

2. There is hereby appropriated from the General Treasury to

1 3. This act shall take effect immediately.

STATEMENT

P. L. 1969, chapter 134 was enacted to provide public support to bus companies in financial difficulty to insure continuance of service. By its terms, P. L. 1969, chapter 134 expires on July 1, 1970. The purpose of this act is to extend the applicability of P. L. 1969, chapter 134 for an additional year. An additional \$500,000.00 is required to replace the \$500,000.00 of the original \$750,000.00 appropriation which was expended during the past year.
