An Act concerning motor vehicles and amending section 39:3-72 of the Revised Statutes.

- 14 inspection of tires mounted on vehicles including visual comparison
- 15 with simple measuring gauges. Said requirements shall encompass
- 16 effects of tread wear and depth of tread. A tire shall be considered
- 17 unsafe if it has: (1) any ply or cord exposed; or (2) any bump,
- 18 bulge or knot affecting tire structure; or (3) any break repaired

Governor William T. Cahill today signed into law Assembly Chap 129 Bill A 515. The measure prohibits the use on New Jersey roads of tires with a tread depth of less than 2/32 of an inch.

The new law goes into effect immediately.

Motor Vehicle Director Ronald M. Heymann, following the Governor's signing of the bill, said,

"The new legislation will help put safer cars on New Jersey's highways by insuring the use of proper tires. The law will be enforced by state and local police and by the Division's inspection stations where personnel have been notified to reject all vehicles with substandard tires."

In 1968, the Federal Government required tire manufacturers to install built-in yellow cords as tread wear indicators. This provides a quick visual check for tires that have been worn to the 2/32 of an inch tread depth.

Richard L. Siegel, President of the New Jersey State Tire

Dealers Association, said the legislation will help guarantee

safer tires and operating conditions on the roads. Siegel also

attended the Bill signing.

Any law enforcement officer, at any time, upon reasonable cause to believe that a vehicle is unsafe or equipped with tires in violation of the provisions of this section or of the rules promulgated here-under, may require the operator of such vehicle to stop and submit such vehicle to an inspection. If the inspection discloses the vehicle to be in violation, the officer may issue a summons for such violation.

1 2. This act shall take effect immediately.
