AN ACT to amend "An act concerning the salaries of surrogates, registers of deeds and mortgages, county clerks and sheriffs in the several counties of the State and repealing certain acts and statutes relating thereto," approved June 12, 1959 (P. L. 1959, c. 96).

1 BE IT ENACTED by the Senate and General Assembly of the State 2 of New Jersey:

1 1. Section 1 of P. L. 1959, chapter 96 (C. 40:38-6.14) is amended 2 to read as follows:

3 1. The board of chosen freeholders in each county may fix by
4 resolution the salaries of surrogate, register of deeds and mort5 gages, county clerk and sheriff as follows:

6 In counties having a population in excess of 600,000, not less than 7 \$12,000.00 or more than [\$20,000.00] \$24,000.00 per annum;

8 In counties having a population in excess of 400,000, but not more 9 than 600,000, not less than \$12,000.00 or more than [\$18,000.00] 10 \$21,000.00 per annum;

In counties having a population in excess of 200,000, but not more
than 400,000, not less than \$10,000.00 or more than [\$15,000.00]
\$18,000.00 per annum;

14 [In counties having a population in excess of 100,000, but not 15 more than 200,000, not less than \$7,500.00 or more than \$12,000.00 16 per annum;

17 In counties having a population in excess of 50,000, but not more 18 than 100,000, not less than \$7,500.00 or more than \$11,000.00 per 19 annum;

In counties having a population of not more than 50,000 not less than \$5,000.00 or more than \$10,000.00 per annum;]

In counties having a population of 200,000 or less, not less than
\$5,000.00 nor more than \$15,000.00.

24 The salaries of such officers shall be paid by the proper county 25 disbursing officer in equal semimonthly payments.

1 2. This act shall take effect January 1, 1971.
