AN ACT concerning manner, means and times of hunting, and supplementing article 2 of chapter 4 of Title 23 of the Revised Statutes.

1 BE IT ENACTED *by the Senate and General Assembly of the State*
2 *of New Jersey:*

1 1. No person shall, except under emergency conditions author-
2 ized by the Division of Fish and Game, kill, destroy, injure, shoot,
3 shoot at, take, wound, or attempt to take, kill, or wound a game
4 bird or game animal, or have in his possession or control any fire-
5 arm or other weapon of any kind, while elevated in a standing tree,
6 or in a structure of any kind within 300 feet of a baited area under
7 a penalty of \$50.00 for each offense.

1 2. For the purpose of this act, "baited area" shall mean the
2 presence of placed, exposed, deposited, distributed, or scattered
3 ****[*edible*]**** agricultural products, salt, or other ****edible**** lure
4 whatsoever capable of attracting, or enticing such birds or animals.
5 Growing and unharvested crops shall not be considered baiting or
6 feeding game birds or game animals.

1 3. This act shall take effect immediately.

EXPLANATION—Matter enclosed in bold-faced brackets [thus] in the above bill
is not enacted and is intended to be omitted in the law.

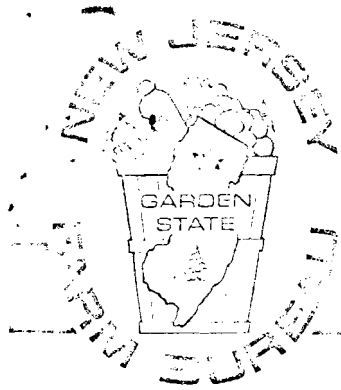

THE FIRST MEETING OF THE FARM BUREAU-GRANGE LEGISLATIVE ACTION COMMITTEE for 1970 was held at the Farmhouse in Trenton on February 6. Farm Bureau Vice President Walter Ellis, Jr. will be chairman of the Committee this year; Grange Master William Schlechtweg will be vice-chairman. Names were appointed to the legislative emergency plan for the year; a priority program was recommended; and the bills already introduced on this priority list are indicated:

1. **MARKETING:** a. Agricultural Commodities Act of 1970, which is an enabling act for research and promotion programs in the form of statewide marketing orders (A.625). Chief sponsor is James Coleman, Monmouth County, plus a number of other legislators. b. Bargaining Cooperative dues deduction bill (S. 625). Chief sponsor is Senator Farleigh Dickinson, Bergen, chairman of the Senate Committee on Agriculture, Conservation and Natural Resources.
2. **EMINENT DOMAIN REVISION** (A. 504) Chief sponsor is Walter Foran, Hunterdon, plus many other legislators.
3. **MILK LEGISLATION:** a. Bill to tighten up the school milk purchase act (S. 438) Chief sponsor is Sen. Forsythe, Burlington plus Sen. Dumont, Sussex-Warren-Hunterdon. b. Bill to remove specific milk definitions from the milk health act, give the Commissioner of Health authority to set up definitions by regulation.
4. **FARM LABOR:** a. Bill to delay effective date of the flush toilet requirement for seasonal farm labor housing. (A. 593) Sponsors: Curcio and Smith, Atlantic; Enos and Black, Gloucester-Salem. b. Bill to provide for an overall revision of the Seasonal Farm Labor Act of 1967. (Now being prepared)
5. **FISH AND GAME:** a. Bill to provide special fishing licenses for migrant workers; b. Bill to outlaw hunting over bait (A. 197). A. Smith, Atlantic, sponsor. c. Bill to provide some leeway to the Director of Fish and Game to deny permits for the carbide exploders, where a municipality passes a resolution charging undue hardship on nearby residents.
6. **PROTECT FARMLAND ASSESSMENT ACT**, while sponsoring some minor changes that will strengthen the program and eliminate some criticism.
7. **SECURE APPROPRIATION OF \$275,000 FOR CREAM RIDGE AND CENTERTON** agricultural research centers.
8. **PESTICIDES:** Will watch this issue carefully, oppose outright bans.
