AN ACT concerning oaths, affirmations and affidavits, and amending section 41:2–1 of the Revised Statutes.

BE IT ENACTED by the Senate and General Assembly of the State 1 $\mathbf{2}$ of New Jersey: 1. Section 41:2-1 of the Revised Statutes is amended to read 1 $\mathbf{2}$ as follows: 41:2-1. All oaths, affirmations and affidavits required to be made 3 or taken by law of this State, or necessary or proper to be made, 4 taken or used in any court of this State, or for any lawful purpose 5 6 whatever, may be made and taken before any one of the following 7 officers: 8 The Chief Justice of the Supreme Court or any of the justices or judges of courts of record of this State; 9 Masters of the Superior Court; 1011 Municipal magistrates; Mayors or aldermen of cities, towns or boroughs or commission-12 ers of commission governed municipalities; 13Surrogates, registers of deeds and mortgages, county clerks and 14 their deputies; 15[City] Municipal clerks; 16Clerks of all courts; 1718 Notaries public; 19 Commissioners of deeds; 20 Members of the State Legislature; Attorneys-at-law and counsellors-at-law of this State. $\mathbf{21}$ 22This section shall not apply to official oaths required to be made 23or taken by any of the officers of this State, nor to oaths or affidavits required to be made and taken in open court. $\mathbf{24}$ 2. This act shall take effect immediately. 1 EXPLANATION—Matter enclosed in **bold-faced** brackets [thus] in the above bill is not enacted and is intended to be omitted in the law.
