# STATE OF NEW JERSEY

### PRE-FILED FOR INTRODUCTION IN THE 1970 SESSION

### By Senator RINALDO

An Act requiring certain reports by the New Jersey Highway Authority and supplementing "The New Jersey Highway Authority Act," approved April 14, 1952 (P. L. 1952, c. 16).

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. Notwithstanding any inconsistent provisions of the act hereby
- 2 supplemented or any other law, the New Jersey Highway Authority
- 3 shall submit to the Governor, the Chairmen of the Appropriations
- 4 Committees of the Senate and General Assembly, and the Director
- 5 of the Division of Budget and Accounting of the Department of the
- 6 Treasury, the following reports:
- 7 a. Within 90 days after the end of each of its fiscal years, a com-
- 8 plete and detailed report of (1) its operations and accomplishments
- 9 during said year; (2) its receipts and disbursements, or revenues
- 10 and expenses, during said year in accordance with the categories or
- 11 classifications established by the authority for its own operating
- 12 and capital outlay purposes and in accordance with such other
- 13 categories and classifications as may be designated by any of the
- 14 persons enumerated in section 1 of this act; (3) its assets and
- 15 liabilities at the end of said year, including the status of reserve,
- 16 depreciation, special or other funds and including the receipts and
- 17 payments of these funds; (4) a schedule of its bonds and notes
- 18 outstanding at the end of said year, together with a statement of
- 19 the amounts redeemed and incurred; and (5) a listing of all con-
- 20 tracts exceeding \$100,000.00 entered into during said year;
- 21 b. Before the close of each of its fiscal years, a complete and
- 22 detailed report of its operating and capital construction budget, in
- 23 the form and detail established by the authority for its own oper-
- 24 ating and capital outlay budget and in such form and detail as may
- 25 be designated by any of the persons enumerated in section 1 of this
- 26 act for the next succeeding fiscal year, including its receipts and

- 27 disbursements, or revenues and expenses, for the prior fiscal year
- 28 and its estimated receipts and disbursements, or revenues and
- 29 expenses, for said year and for the succeeding fiscal year.
- 2. This act shall take effect immediately.
