AN ACT to amend "An act fixing the compensation of guards, keepers, orderlies and industrial officers in the county jails, houses of detention and penitentiaries in certain counties of the first class," approved June 8, 1966 (P. L. 1966, c. 68).

1 BE IT ENACTED *by the Senate and General Assembly of the State*
2 *of New Jersey:*

1 1. Section 1 of P. L. 1966, chapter 68 (C. 30:8-13.1) is amended
2 to read as follows:

3 1. Notwithstanding the provisions of any other law, the salaries
4 of the guards, keepers, industrial officers and guard orderlies,
5 *correction officers*, employed in the jails, houses of detention and
6 penitentiaries in counties of the first class having less than 700,000
7 inhabitants, shall be [not less than \$5,500.00 per annum and shall
8 not exceed \$7,600.00 per annum, with provision for increments in
9 salary between the minimum and maximum of such salaries to be]
10 fixed by the board of chosen freeholders.

11 This section shall not be construed to permit the decrease of any
12 salaries now authorized by law to be paid to any of the guards,
13 keepers, industrial officers, *correction officers*, and guard orderlies,
14 affected by this section nor decrease the amount of each increment
15 now being paid.

1 2. This act shall take effect immediately.

Governor William T. Cahill today signed into law two bills giving Freeholders in Hudson County the power to set salaries for court attendants and employees of county jails.

Cahill expressed his pleasure in signing the bills and said:

"It is my belief that salary ranges for local employees should be set by local officials."

Assembly bill 451, sponsored by Alfred E. Suminski (D., Hudson), provides that the salaries of guards, helpers, industrial officers and correction officers in first-class counties with populations of less than 700,000 shall be set by the freeholders. The present salary range is \$5,500 to \$7,600.

The second bill, A-452, which was also introduced by Suminski, provides that salaries of court attendants in first-class counties with less than 700,000 population shall be set by the freeholders. The present salary range is from \$4,500 to \$6,000.
