AN ACT concerning a plan for the providing and apportionment of insurance coverage in certain cases and supplementing Title 17 of the Revised Statutes.

- Be it enacted by the Senate and General Assembly of the State 1
- 2 of New Jersey:
- 1. The Commissioner of Insurance ** [shall] ** ** may ** adopt, 1
- issue and promulgate rules and regulations establishing a plan for 2
- the providing and apportionment of insurance coverage for appli-3
- cants therefor who are in good faith entitled to, but are unable to
- procure the same, through ordinary methods. Every insurer ad-
- mitted to transact and transacting any line, or lines, of insurance
- in the State of New Jersey shall participate in such plan and pro-
- vide insurance coverage to the extent required in such rules and

- Prior to the adoption or amendment of such rules and regula-9
- tions, the commissioner shall consult with such members of the 10
- insurance industry as he deems appropriate. Such consultation 11
- shall be *[in lieu of] * *in addition to* any otherwise required 12
- public hearing or notice with regard to the adoption or amendment
- of rules and regulations.
- 2. This act shall take effect immediately.

EXPLANATION—Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted in the law.
