AN ACT concerning toy caps and amending R. S. 21:3-2.

- 1 Be it enacted by the Senate and General Assembly of the State

- 21:3-2. It shall be unlawful for any person to offer for sale, 2
- expose for sale, sell, possess or use, or explode any blank cartridge, 3

- used; the type of balloon which requires fire underneath to propel 5
- the same; firecrackers; torpedoes; skyrockets, Roman candles, 6
- bombs, sparklers or other fireworks of like construction, or any 7

- any tablets or other device commonly used and sold as fireworks 9
- containing nitrates, chlorates, oxalates, sulphides of lead, barium, 10

- substance or combination of substances, or article prepared for 13
