The financial operation of all the numicipalities in the State has become so complex that it requires a competent, trained finance officer to supervise and carry out the financial operations efficiently. It is essential that manicipal governments be operated as economically and efficiently as possible to keep the burden of local taxes as light as possible. Professional personnel are the greatest factor in insuring competent financial management of the fiscal affairs of every municipality. Courses now offered by Rutgers University are designed to train the finance officer in the duties of his position. An Act to provide for the qualification and certification of municipal finance officers, authorizing the creation by ordinance of the office of municipal finance officer, and supplementing chapter 46 of Title 40 of the Revised Statutes.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1 1. As used in this act:
- 2 a. "Director" means the Director of the Division of Local
- 3 Finance.
- 4 b. "Municipal finance officer" means a municipal director of
- 5 finance, municipal comptroller or municipal treasurer who is not
- 6 a member of the governing body of a municipality.
- 1 2. Commencing on the effective date of this act, the Director
- 2 of the Division of Local Finance, hereinafter referred to as the
- 3 director, shall accept applications for certification as municipal
- 4 finance officer. An applicant shall present to the director written
- 5 application on forms provided by the Division of Local Finance,
- 6 showing that the applicant is not less than 21 years of age, is a
- 7 citizen of the United States, is of good moral character, has obtained
- 8 a certificate or diploma issued after at least 4 years of study in an
- 9 approved secondary school or has received an academic education
- 10 considered and accepted by the Commissioner of Education of this
- 11 State as fully equivalent, and has graduated from a 4-year course
- 12 at a college of recognized standing, with a major course of study
- 13 in business administration, accounting or some related subject. An
- 14 applicant who does not meet the college education requirement may
- 15 substitute experience in a position as director of finance, comp-

- 4. Notwithstanding the qualifications established in section 1 of
- 2 this act, a municipal finance officer certificate shall be issued to
- 3 any person who is licensed as a registered municipal accountant in
- 4 the State of New Jersey who shall make application as required
- 5 in section 1 of this act, and who shall furnish proof that he has
- 6 received a certificate indicating satisfactory completion or instruc-
- 7 tion of a training course in principles of financial management,
- 8 or such other training course as is certified as its equivalent by
- 9 Rutgers University, The State University of New Jersey, and
- 10 approved by the Division of Local Finance of the State, upon pay-
- 11 ment of a fee of \$25.00 to the order of the Treasurer of the State
- 12 of New Jersey.
- 5. Any municipal finance officer certificate may be revoked or
- 2 suspended by the director for dishonest practices or failure, neglect
- 3 or refusal to comply with the Constitution of the State of New
- 4 Jersey or the laws relating to local finance, or other just cause.
- 5 Request may be made to the director by any governing body of any
- 6 municipality for a review of the behavior or practices of a certified
- 7 finance officer when the governing body may feel his certificate
- 8 should be revoked. No certificate shall be revoked or suspended
- 9 except upon a proper hearing before the director or his designee,
- 10 after 14 days notice to the finance officer. If the municipal finance

ASSEMBLY BILL NO. 873

To the General Assembly:

Pursuant to Article V, Section I, Paragraph 14(b) of the Constitution, I herewith return Assembly Bill No. 873, with my objections, for reconsideration.

Assembly Bill No. 873 provides for the qualification and certification of municipal finance officers and, additionally, would enable the governing body of a municipality to create the office of municipal finance officer by ordinance. The object of this bill which is to encourage increased professionalism within this key position is highly desirable.

I note, however, in my review of this bill, that sections 6 and 7, while authorizing municipalities to establish the office of municipal finance officer by ordinance failed to provide safeguards for those individuals presently employed in the performance of duties which would belong to the municipal finance officer, if such a position were created. I believe that this might result in a number of highly competent people being unduly prejudiced by the creation of the office of municipal finance officer by ordinance. If at some time in the future the Legislature, in its wisdom, chooses to allow the governing body of a municipality to create by ordinance the office of municipal finance officer, I would respectfully recommend that they provide the necessary safeguards to protect those serving at that time.

Accordingly, I herewith return Assembly Bill No. 873, and respectfully recommend the following changes:

Pages 2 and 3, Section 6, Lines 1 - 9: Omit in its entirety. .

Page 3, Section 7, Lines 1 - 7: Omit in its entirety.

Page 3, Section 8, Line 1: Delete "8." and insert "6."

Page 3, Section 9, Line 1: Delete "9." and insert "7."
