- 5 trary, the * governing body of any municipality * * employer * may
- 6 assume the entire cost of such coverage and pay all the premiums
- 7 for employees who have retired after 25 years or more service
- 8 with the *[municipality, and their dependents] * *employer, in-
- 9 cluding the premiums on their dependents, if any*, under such
- 10 uniform conditions as the governing body shall prescribe.
- 1 2. This act shall take effect immediately.

FISCAL NOTE TO **SENATE No. 802**

Senate Bill No. 802 is permissive legislation which would allow the governing body of any municipality to assume the entire cost of health insurance premiums for employees and their dependents, if the employee retired after 25 years of service. What this would mean in terms of cost to local governments is speculative as there is no way to determine how many municipalities would exercise this option.

Adoption of this legislation would not bring about additional costs to the State.

In compliance with written request received, there is hereby submitted a fiscal estimate for the above bill, pursuant to P. L. 1962, c. 27.
