An Act creating a School Budget Review Board in the Department of Education, amending N. J. S. 18A:22-38, and supplementing chapter 22 of Title 18A of the New Jersey Statutes.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. This act may be known and cited as the "School Budget Re-
- 2 view Board Act of 1973."
- 1 2. N. J. S. 18A:22-38 is amended to read as follows:
- 2 18A:22-38. If said governing body or bodies shall fail so to
- 3 certify any amount, determined by them to be necessary for any
- 4 item rejected at the annual school election, or in event that the
- 5 governing bodies of the municipalities comprising a school district.
- 6 shall certify different amounts, then the [commissioner] School
- 7 Budget Review Board shall determine the amount or amounts
- 8 which in [his] its judgment, are necessary to be appropriated, for
- 9 each of the items appearing in the budget, submitted to such gov-
- 10 erning body or bodies, to provide a thorough and efficient system of
- 11 public schools in the district, and certify to the county board of
- 12 taxation the totals of the amount so determined to be necessary
- 13 for each of the following:
- a. Current expenses of schools;
- b. Vocational evening schools or classes;
- 16 c. Evening schools or classes for foreign-born residents;
- d. Appropriations to capital reserve fund; or
- e. Any capital project, the cost whereof is to be paid directly
- 19 from such taxes; and the amounts so certified shall be included in
- 20 the taxes to be assessed, levied and collected in such municipality
- 21 or municipalities for such purposes.

EXPLANATION—Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted in the law.

- 3. A School Budget Review Board is hereby created in the De-
- 2 partment of Education for the purpose of reviewing school budgets
- 3 which have been rejected by the voters in a school election and of
- 4 making fiscal recommendations in connection therewith.
- 4. The board shall consist of seven members, the Commissioner
- 2 of Education, who shall serve ex officio and six members to be
- 3 appointed by the Governor as follows: two members from the field
- 4 of education, two local elected officials, not more than one of whom
- 5 shall be a member of a board of education, and two citizen mem-
- 6 bers, one of whom shall be a registered municipal accountant of
- 7 New Jersey or a certified public accountant of New Jersey who
- 8 shall hold an uncanceled registration license as a public school
- 9 accountant for New Jersey.
- 10 Each member of the board, except the members first appointed
- 11 and the Commissioner of Education, shall serve for a term of 2
- 12 years. Each member shall hold office until the appointment of his
- 13 successor. The initial appointments to the board shall be three
- 14 members for a term of 1 year and three members for a term of
- 15 2 years.
- Vacancies shall be filled for the unexpired term only. Members
- 17 of the board shall serve without compensation but shall be entitled
- 18 to be reimbursed for all reasonable and necessary expenses.
 - 1 5. The board shall meet at the call of the Governor as soon as
 - 2 may be following selection of its members, and shall organize by
 - 3 the selection of a chairman from among its membership and a
- 4 secretary who need not be a member. The board shall fix the date
- 5 for its organization meeting and the dates for other regular meet-
- 6 ings during each year.
- 6. It shall be the duty and responsibility of the board to:
- 2 a. Hear appeals from governing bodies concerning school
- 3 budgets which have been rejected by the voters in the school
- 4 district;
- 5 b. Review the budgets of school districts and determine the
- 6 amount or amounts necessary to provide a thorough and efficient
- 7 system of public schools.
- 7. This act shall take effect immediately.
