An Act to repeal "An act concerning county mosquito extermination commissions in certain counties, and supplementing chapter 9 of Title 26 of the Revised Statutes," approved September 10, 1948 (P. L. 1948, c. 387).

## SPONSOR'S STATEMENT

Presently members of county mosquito extermination commission are appointed by the board of freeholders of their respective counties, except counties of not less than 325,000 nor more than 400,000 population where the judges of the county make the appointment. This exception is provided by the act which this bill repeals. It applied only to Camden county, but since the last census it no longer applies to Camden county and due to population growth now applies to Morris county, which was never the intent of the act. The act therefore is outdated and must be repealed.
