AN ACT concerning prepayment penalties on mortgage loans and amending section 2 of P. L. 1968, c. 54 (C. 46:10B-2).

1 BE IT ENACTED by the Senate and General Assembly of the State 2 of New Jersey:

1 1. Section 2 of P. L. 1968, c. 54 (C. 46:10B-2) is amended to 2 read as follows:

2. Prepayment of a mortgage loan may be made by or on behalf
of a mortgagor at any time, and the holder of the mortgage loan
shall be entitled to charge and collect a fee for the exercise of the
right of such prepayment according to the following schedule:

7 (a) If prepayment is made within the first year from the date
8 of such mortgage loan, the prepayment fee shall not exceed 3%
9 of the face amount of the mortgage loan;

10 (b) If prepayment is made on or after 1 year from the date 11 of the mortgage plan, but within [3] 2 years from such date, the 12 prepayment fee shall not exceed 2% of the face amount of the 13 mortgage loan;

(c) If prepayment is made on or after [3] 2 years from the
date of the mortgage loan, but within [5] 3 years from such date,
the prepayment fee shall not exceed 1% of the face amount of the
mortgage loan;

(d) If prepayment is made on or after [5] 3 years from the
19 date of the mortgage loan, no fee shall be charged or collected
20 therefor.

1 2. This act shall take effect immediately.
