

#### STATEMENT

This bill enables the State Treasurer to designate the Deputy State Treasurer or any other officer or employee of the Department of the Treasury to sit and act in behalf of the State Treasurer on the board of trustees, commission or council administering the Public Employees' Retirement System, Teachers' Pension and Annuity Fund, Police and Firemen's Retirement System, Consolidated Police and Firemen's Pension Fund, Prison Officers' Pension Fund, State Police Retirement System, Supplemental Annuity Collective Trust and Health Benefits Commission.

## STATE OF NEW JERSEY

DATED: MARCH 25, 1974

This bill, as amended by the Senate State Government and Federal and Interstate Relations Committee, enables the State Treasurer to designate the Deputy State Treasurer or any other officer of the Department of the Treasury to sit and act on behalf of the State Treasurer on the board of trustees, commission or council administering the Public Employees Retirement System, Teachers' Pension and Annuity Fund, Police and Firemen's Fund, Prison Officer's Pension Fund, State Police Retirement System, Supplemental Annuity Collective Trust and Health Benefits Commission. The language or the original bill would have enabled the State Treasurer to designate any employee of the Department to sit in his behalf. The Committee amendment limits the designation to officers of the Department to guarantee attendance by members of the Department whose level of responsibility would enable them to act with authority on the matters considered by the subject boards, commissions and councils.
