

An Act providing for the appointment of deputy commissioners in the Department of Institutions and Agencies, amending R. S. 30:1-9, and supplementing chapter 1 of Title 30 of the Revised Statutes.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. The commissioner shall be assisted in the performance of his
- 2 duties by two deputy commissioners. Each deputy commissioner
- 3 shall be appointed by and shall serve at the pleasure of the com-
- 4 missioner, and until his successor has been appointed and qualified.
- 5 Each deputy commissioner shall exercise such powers and per-
- 6 form such duties as the commissioner shall prescribe.
- 7 Unless otherwise provided by law, each deputy commissioner
- 8 shall receive such salary as may be established by the commissioner
- 9 with the approval of the President of the Civil Service Commission
- 10 and the Director of the Division of Budget and Accounting.
- 11 The commissioner may designate one of the deputy commis-
- 12 sioners to exercise the powers and perform the duties of the com-
- 13 missioner during his disability or absence.
- 1 2. R. S. 30:1-9 is amended to read as follows:
- 2 30:1-9. The commissioner may create within the department
- 3 such divisions as he may deem necessary. Each division shall be
- 4 under the supervision of a director, who shall be qualified by train-
- 5 ing and experience, appointed by and receive the compensation
- 6 fixed by the commissioner, except where otherwise provided by EXPLANATION—Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted in the law.

- 9 The commissioner may in his discretion combine the duties of
- 10 two or more divisions under one head.
- 11 The division directors shall perform such services and exercise
- 12 such powers at such times and places as the commissioner shall

- 14 The commissioner may from time to time designate one of the
- 15 division directors to exercise the powers and perform the duties
- 16 of the commissioner during his disability or absence.]
- 1 3. This act shall take effect immediately.

STATEMENT

This bill will create two deputy commissioners in the Department of Institutions and Agencies. Each deputy commissioner shall assist the commissioner in the performance of his duties.
