PRE-FILED FOR INTRODUCTION IN THE 1974 SESSION

An Act to amend the "Public Employees' Retirement System Act," approved June 28, 1954 (P. L. 1954, c. 84) as the short title thereof was amended by P. L. 1971, c. 213.

1 BE IT ENACTED by the Senate and General Assembly of the State 2 of New Jersey:

1 1. Section 54 of P. L. 1954, c. 84 (C. 43:15A-54) is amended to 2 read as follows:

54. If any change or error **[**in records**]** results in an employee or beneficiary receiving from the retirement system more or less than he would have been entitled to receive **[**had the records been correct**]**, then on discovery of the error, the retirement system shall correct it and, so far as practicable, adjust the payments in such a manner that the actuarial equivalent of the benefit to which he was correctly entitled shall be paid.

10 The application of any member for prior service credit or credit 11 for all previous service shall be approved if the employer, for whom 12 the service was rendered stipulates, in writing, to the retirement 13 system that the information necessary for the award of such credit 14 was not presented to the employee and agrees to make the necessary 15 additional contribution to the contingent reserve fund and the 16 employee makes the required contributions, if any.

1 2. This act shall take effect immediately.

EXPLANATION—Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted in the law.

This bill amends the "Public Employees' Retirement System Act" in order to permit an employee, who would receive from the retirement system more or less than the amount to which he is entitled, due to any change or error, whether such error is recorded or not, to receive the payments to which he is entitled.

The receipt of such adjusted payments is contingent on the written stipulation by the employer for whom the employee rendered service that the information necessary for the award of credits was not presented to the employee. The employer must also agree in writing to make the necessary additional contribution to the reserve fund.

Further, the employee must also make the required contributions, if any.
