SUMMARY

Synopsis: Establishes Trenton Capital City Aid Program; appropriates \$10

million.

Type of Impact: Increase in State expenditures from Property Tax Relief Fund;

County, and Trenton School District.

- The Office of Legislative Services ("OLS") estimates that enacting this bill would increase State expenditures by \$10 million in FY 2019 and at least \$10 million each fiscal year thereafter. The bill would also result in corresponding increases in revenue for the City of Trenton, and in certain circumstances, Mercer County and the Trenton School District.
- The bill establishes the Trenton Capital City Aid Program, which would provide at least \$10 million in annual aid to the City of Trenton solely for the purposes of property tax relief. The bill also appropriates \$10 million from the Property Tax Relief Fund to the Department of Community Affairs ("DCA") to administer the program in FY 2019.
- The bill requires that in any year the Trenton Capital City Aid dedicated to Trenton exceeds the city's property tax levy, the remaining balances would be equally distributed to Mercer County and the Trenton School District for property tax relief. In this event, there would be an indeterminate revenue increase for the county and the school district.

BILL DESCRIPTION

The bill establishes the Trenton Capital City Aid Program, which would provide at least \$10 million in annual State aid to the City of Trenton to be used exclusively for the purpose of

reducing the amount to be raised through property taxation for municipal purposes. However, if in any year the amount of Trenton Capital City Aid dedicated to the city exceeds the amount required to be raised through property taxation for municipal purposes, the remaining aid would be allocated in equal amounts to Mercer County and the Trenton School District for the purposes of reducing the amounts to be raised through property taxation for county and school purposes.

The bill appropriates \$10 million from the Property Tax Relief Fund to the Department of Community Affairs for the Trenton Capital City Aid Program in State Fiscal Year 2019.

FISCAL ANALYSIS

OFFICE OF LEGISLATIVE SERVICES

The OLS estimates that enacting this bill would increase State expenditures by \$10 million in FY 2019 and at least \$10 million each fiscal year thereafter. The bill would also result in corresponding increases in revenue for the City of Trenton, and in certain circumstances, Mercer County and the Trenton School District.

Most notably, the bill establishes the Trenton Capital City Aid Program, which would provide at least \$10 million in annual State aid to the City of Trenton solely for the purposes of property tax relief. The bill also appropriates \$10 million from the Property Tax Relief Fund to the DCA to administer the program in FY 2019. The distribution of Trenton Capital City Aid represents a corresponding increase in DCA expenditures and local revenue.

The bill requires that in any year the amount of Trenton Capital City Aid dedicated to Trenton exceeds the city's property tax levy, the remaining balances would be equally distributed to Mercer County and the Trenton School District for property tax relief. In this event, there would be an indeterminate revenue increase for the county and the school district. However, the OLS notes that Trenton's municipal tax levy equaled approximately \$80.83 million in 2017 and \$82.96 million in 2018. As a result, the OLS does not expect the county or school district to receive additional funding through the Trenton Capital City Aid Program.

TRENTON – Today, Governor Phil Murphy signed the following bills into law:

A5381 (Reynolds-Jackson, Verrelli/Turner) – Authorizes State Treasurer to sell surplus real property located in City of Trenton, Mercer County.

S2863 (Sarlo, Sweeney/Benson, Jones, Calabrese) – Revises requirements for grant recipients of Transportation Trust Fund Authority local aid program.

S2920 (Smith, Bateman, Greenstein/McKeon, Pinkin, Zwicker) – Establishes funding allocations for constitutionally dedicated CBT revenues for Fiscal Year 2020 and thereafter and revises law for State's open space, farmland, and historic preservation programs; appropriates \$500,000.

S3164 (Greenstein, Diegnan/Benson, Lopez, Murphy) – "New Jersey Transit Corporation Employee Protection Act"; prohibits NJT from asserting sovereign immunity in certain situations and subjects NJT to certain federal statutes and regulations.

S3587 (Turner/Reynolds-Jackson, Verrelli) – Establishes Trenton Capital City Aid Program; appropriates \$10 million.

S3651 (Pou, Singleton/Conaway, Mukherji) - Revises law concerning Medicare supplement insurance coverage.
