"Continuing care retirement community" is defined in the bill as
a continuing care facility operating under a certificate of authority
issued by the Department of Community Affairs (DCA) pursuant to
P.L.1986, c.103 (C.52:27D-330 et seq.), and as a retirement
community registered with DCA pursuant to P.L.1977, c.419
(C.45:22A-21 et seq.).

The Assembly Health and Senior Services Committee reports favorably and with committee amendments Assembly Bill No. 3890.

As amended, this bill requires the Department of Health (DOH) to prepare and make available on its website, in an easily printable format, information about the influenza vaccine for older adults. This information will include the role the influenza vaccine plays in the prevention of influenza in older adults, the availability and efficacy of the influenza vaccine for older adults, and a recommendation that each person consult with a physician to determine if receiving the influenza vaccine is recommended and appropriate for that person. DOH may additionally provide such information as it deems necessary and appropriate, including, but not limited to: the health risks and complications associated with, and the morbidity and mortality rates among older adults suffering from, influenza; the individual and community benefits of inoculating older adults living in close proximity to each other, especially those living in continuing care retirement communities; and influenza vaccination programs and health care providers providing influenza vaccinations to older adults.

Under the bill, DOH will require each continuing care retirement community in the State to post this influenza vaccination information in a conspicuous public place in the facility no later than August 1 of each year.

#### COMMITTEE AMENDMENTS:

The committee amendments make certain revisions to the information to be provided by the Department of Health concerning influenza vaccinations for older adults. The department will be required to provide information concerning the role the influenza vaccine plays in the prevention of influenza in older adults, the availability and efficacy of the influenza vaccine for older adults, and a recommendation that each person consult with a physician to determine if receiving the influenza vaccine is recommended and appropriate for that person. The department will additionally have discretion to provide any other information it deems necessary and appropriate.

The committee amendments remove a requirement that the influenza vaccine information be individually distributed to each resident of a continuing care retirement community.

The committee amendments make certain technical revisions to the bill.

with Senate Floor Amendments (Proposed by Senator GORDON)

### ADOPTED: MARCH 16, 2015

These floor amendments clarify that the Department of Community Affairs (DCA) must require each continuing care retirement community in the State to post information about the influenza vaccine for older adults provided by DCA in a conspicuous public place in the facility no later than August 1 of each year.

The amendments also provide that nothing in the bill shall be deemed to require any person in a continuing care retirement community to receive an influenza vaccine.

Finally, the amendments provide that the Commissioners of Health and Community Affairs may adopt rules and regulations to effectuate the purposes of the bill. As introduced, the bill required the Commissioner of Health to adopt rules and regulations.

### Governor Christie Takes Action To Help Prevent Over-the-Counter Drug Abuse

**Trenton, NJ** – Adding to the Administration's broad-based approach of preventing and treating drug addiction, Governor Christie took action today to prohibit the sale of medications containing dextromethorphan, a substance found in more than 120 over-the-counter cold medications, to any person under the age of 18 unless they have a prescription. The legislation, A-622/1469 (Moriarty, Diegnan, Wimberly, Vainieri Huttle, Gusciora, Sumter, Angelini, Munoz/Barnes), addresses the growing problem of teenagers overusing or abusing dextromethorphan to get high, leading them down a path of addiction in the future.

The bill also requires the Department of Health to post a link on its website containing a list of products in which dextromethorphan is an active ingredient. The new law will take effect on Feb. 1, 2016.

The Governor also took the following action on other pending legislation:
