PRE-FILED FOR INTRODUCTION IN THE 1969 SESSION

By Senator SISCO

AN ACT to amend "An act creating the New Jersey Racing Commission and defining its powers and duties; providing for the granting of permits and licenses for the operation of race meeting whereat the running, steeplechase racing or harness racing of horses only may be conducted; providing for the licensing of concessionaires and operators and their employees; regulating the system of pari-mutuel betting and fixing the license fees, taxes and revenues imposed hereunder and fixing penalties for violations of the provisions of this act," approved March 18, 1940 (P. L. 1940, c. 17), as said Title was amended by chapter 137 of the laws of 1941.

1 BE IT ENACTED by the Senate and General Assembly of the State  
2 of New Jersey:

1 1. Section 4 of the act of which this act is amendatory is amended  
2 to read as follows:

3 4. The commissioners shall receive no salaries but shall be allowed  
4 reasonable expenses incurred in the performance of their official  
5 duties in an amount not exceeding **[\$2,000.00]** \$5,000.00 per annum  
6 in the case of the chairman, and **[\$1,000.00]** \$3,500.00 per annum in  
7 the case of each of the other commissioners. The commission may  
8 employ a secretary, a chief inspector and such other assistant  
9 secretaries, and inspectors, clerks, stenographers, and other em-  
10 ployees as may be necessary to carry out the provisions of this  
11 act, all of whom shall have been actual residents of the State of New  
12 Jersey for at least 5 years and shall serve during the pleasure of  
13 the commission and receive such compensation and perform such  
14 duties as the commission may determine; provided, however, that  
15 no person shall be employed by the commission or hold any office  
16 or position under the commission who holds an official relation to  
17 any association or corporation engaged in or conducting horse

EXPLANATION—Matter enclosed in bold-faced brackets [thus] in the above bill  
is not enacted and is intended to be omitted in the law.

18 racing or who holds stock or bonds therein, or who has any pecuni-  
19 ary interest therein. The provisions of Title 11, Revised Statutes,  
20 and acts amendatory thereof and supplemental thereto, shall be  
21 construed to extend to all of the offices, positions and employments  
22 mentioned in this section with the exception of the following:  
23 commissioners, secretary, assistant secretaries, chief inspector,  
24 assistant inspectors, and all special and part-time employees.

1 2. This act shall take effect July 1, 1969.
