Governor Richard J. Hughes today signed into law the following bills:

Senate Bill No. 446 - which amends the provisions in the law regarding the State Library and State Museum. It modernizes the law, defines the duties and responsibilities of the State Librarian and his Advisory Council, and is patterned closely upon the accepted Standards for Library Functions at the State Level of the American Library Association.

Senate Bill No. 585 - which provides that railroad passes issued to State employees and other officials of the State government are not valid on interstate trains which do not provide intrastate service, or on extra fare or special purpose trains.

Assembly Bill No. 137 - which authorizes the gift of all or part of a human body after death for specified purposes and under certain conditions. The bill was originally proposed in 1968 by the National Conference of Commissioners of Uniform State Laws. This act will help to bring uniformity in an area where there had been great diversity of statutory provisions.

Assembly Bill No. 416 - which simplifies the identification procedures for polling places, eliminating the necessity for a metes and bounds description of the polling place but requiring the address and telephone number.

Dear Colleague:

On September 9th the Governor signed the amended N.J. State Library Law. (Chapter 158 of the Laws of 1969). This amendment, resulting from two years of study by the State Library staff, was approved by the Advisory Council of the State Library and the Department of Education before being introduced in the Legislature.

In essence Chapter 158 modernizes the law, defines the duties and responsibilities of the State Librarian and the Advisory Council, and is patterned closely upon the American Library Association <u>Standards for Library Functions</u> at the State Level.

The separation of the provisions affecting the State Library from those affecting the State Museum made it possible to amend the State Library Law without disrupting the present law governing the State Museum. The new law reflects the differing aims and concerns of these two institutions.

In line with the greater responsibilities and the amounts of state and federal funds now administered by the State Library, the new law authorizes increasing the membership of the Advisory Council from five to eight in order to bring additional lay opinion and advice to bear upon such crucial matters as rules and regulations, minimum standards, apportionment of state aid, and the State's library development program. The Commissioner of Education is cited in the amendment as an ex officio member of the Council. (more)

Considerably more freedom is afforded the State Librarian in organizing the Division to respond to current demands and programs. The amendment thus specifies the services to be rendered by the Library, rather than the Bureaus which would administer them. Among services now clarified in the Library law for the first time are the following:

- * maintenance of library resources and information services over a broad range of subjects which affect the educational, intellectual, cultural, economic, and political life of the State;
- * coordination of a statewide system of libraries in New Jersey;
- * study of library problems throughout the State;
- * library service for the blind and handicapped;
- * documents depository service;
- advisory service for libraries in institutions of higher education,
 and special libraries;
- * advisory service for libraries in State Departments, institutions, and agencies;
- * records management for State and local governments.

In many ways, the amendment simply catches up with activities the Library has had to assume in the past. But the wording has been cleared of much dead wood, and should provide sufficient flexibility to serve as a legal base for many years to come.

Title 18A, Chap. 73 (P.L. 1967, c. 271)

The State Librarian: graduate of an accredited college or university; have had I year of training in a school of library science accredited by ALA; at least 4 years of library experience in a responsible admin. capacity. 18A:73-4.

Powers and Duties: direct and administer the division; administer all laws which by their terms are included under the jurisdiction of the Division; prescribe the powers and duties of Bureau heads except as may be otherwise provided by law; prescribe rules and regulations subject to approval by the Commissioner, as may be necessary. 18A:73-6; 18A:73-7.

- (b) Advise and consult with the Director with respect to the functions of the Division;
- (c) Study and evaluate the public services rendered by the Division and recommend to the Director appropriate items for addition to its collections. 18A:73-11.

New Law: Title 18A, Chap. 73, (amended by P.L. 1969, c.158.)

State & local governments; a deposit and exchange service for library materials; an interlibrary loan service; an advisory service for public libraries, school libraries, libraries of institutions of higher education, industrial, commercial and other special libraries, State department and agency libraries, and the libraries the State maintains within institutions carrying out its health, welfare and correctional programs, and a library service for the handicapped, and provide such other services as may be required by law.
