AN ACT prescribing the powers of members of a county park police system in counties operating a public park or public recreation place pursuant to subdivision B of Article 5 of chapter 37 of Title 40 of the Revised Statutes and amending section 2 of chapter 120 of the laws of 1962.

1 BE IT ENACTED *by the Senate and General Assembly of the State*
2 *of New Jersey:*

1 1. Section 2 of chapter 120 of the laws of 1962 (C. 40:37-95.41)
2 is amended to read as follows:

3 2. The chief and officers of the park police may arrest on view
4 and without warrant, and conduct before the municipal court of
5 the municipality in which the arrest is made, or the municipal court
6 of a neighboring municipality, any person found violating the rules
7 and regulations enacted by the commission for the protection,
8 preservation, regulation and control of the park, parkways, play-
9 grounds and recreation places and all property therein, and in
10 addition **[shall have all the powers conferred by law on police**
11 **officers or constables in the enforcement of the laws of this State**
12 **and the apprehension of violators thereof.]** *while on duty anywhere*
13 *within the territorial limits of the county, shall have the same*
14 *powers for the enforcement of the laws of this State and the*
15 *apprehension of violators thereof as are conferred by law upon*
16 *police officers or constables.*

1 2. This act shall take effect immediately.

STATEMENT

The purpose of this bill is to permit county park police, while on duty, to apprehend within their respective counties, persons violat-

ing the laws of this State despite such violations occurring outside of the territorial limits of the county parks. This bill is a companion bill to proposed amendments to Revised Statutes 40:37-155, 40:37-203, and 40:37-262.
