AN ACT to amend "An act concerning the practice of medicine and surgery and chiropractic, and amending sections 45:9-1, 45:9-12, 45:9-16, 45:9-22 and 45:9-26 of the Revised Statutes and sections 45:9-5.1 and 45:9-14.5 added to the Revised Statutes by chapter 115 of the laws of 1939, and supplementing chapter 9 of Title 45 of the Revised Statutes," approved July 14, 1953 (P. L. 1953, c. 233).

1 BE IT ENACTED *by the Senate and General Assembly of the State*
2 *of New Jersey:*

1 1. Section 10 of the act of which this act is amendatory is
2 amended to read as follows:

3 10. Any applicant to take an examination leading to the granting
4 of a license to practice chiropractic in New Jersey, who has been
5 graduated from an approved chiropractic school after December
6 31, 1957, must, in addition to the other requirements of this act,
7 have successfully completed prior to commencing his or her courses
8 of study in an approved school of chiropractic at least 1 year's
9 study in a school or college of arts and sciences accredited by the
10 State Department of Education and if such applicant has been
11 graduated from an approved chiropractic school after December
12 31, 1958, any such applicant must **[have completed prior to com-**
13 **mencing his or her courses of study in the approved school of**
14 **chiropractic]** *complete* at least 2 years' study in a school or college
15 of arts and sciences accredited by the State Department of Educa-
16 tion *no less than 1 1/2 years of which shall have been completed prior*
17 *to commencing his or her courses of study in the approved school*
18 *of chiropractic.* Successful completion of the aforementioned study
19 prior to commencing the courses of study in an approved school of
20 chiropractic shall be evidenced by a certificate issued by the Com-
21 missioner of Education of this State to that effect.

1 2. This act shall take effect immediately.
