#### INTRODUCED MAY 1, 1969

AN ACT relating to county park commissions in counties of the first class governed by the provisions of sections 40:37-96 to 40:37-174, and supplementing subdivision C of article 5 of chapter 37 of Title 40 of the Revised Statutes.

1 BE IT ENACTED by the Senate and General Assembly of the State 2 of New Jersey:

1. To meet the further expenses to be incurred by counties of the 1  $\mathbf{2}$ first class under the provisions of sections 40:37-96 to 40:37-174 of the Revised Statutes, to which this act is a supplement, for the 3 4 acquisition, development and improvement of parks and parkways, in counties of the first class in this State, in which said sections  $\mathbf{5}$ of the Revised Statutes are, or shall hereafter be, operative, the 6 board of chosen freeholders in any such county may, from time 7 to time, in addition to any bonds theretofore authorized by law, 8 on the request of the board of park commissioners in any such 9 county, in the name and on the credit of the said county, borrow 10money by issuing the bonds of said county to a sum not exceeding 11 in the aggregate \$1,500,000.00 over and above the total amount 12theretofore authorized by law. Such bonds shall be issued in ac-13 cordance with the provisions of chapter 2 of Title 40A of the New 14 Jersey Statutes (sections 40A:2-1 et seq.). The proceeds of the 15sale of the said bonds after deducting expenses for negotiating 16 the same and for engraving, and all other expenses connected with 17 their issue and sale, shall be paid over to the said park commission. 18 2. This act shall take effect immediately. 1
