ASSEMBLY BILL NO. 839

To the General Assembly:

In accordance with Article V, Section I, Paragraph 14(b) of the Constitution, I herewith return Assembly Bill No. 839 for reconsideration with my objections.

This bill provides that the annual salary of each commissioner in cities of the fourth class, having a population of not less than 50,000, and having the commission form of government, may be fixed by ordinance at not less than \$15,000 nor more than \$22,000, and that of the mayor at \$2,500 above that fixed for the other commissioners. It is the mandatory minimum salary required by this bill which is offensive and which makes it impossible for me to approve. The responsibility of changes in the salaries of the commissioners and mayors should be left entirely to the discretion of local authorities and should not be dictated by mandatory legislation.

Accordingly, I return Assembly Bill No. 839 for reconsideration and recommend that it be amended as follows:

In Section 1, Line 10: Delete "less than \$15,000.00 or".
