An Act concerning education and amending section 18A:64A-9 of the New Jersey Statutes.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. Section 18A:64A-9 of the New Jersey Statutes is amended to
- 2 read as follows:
- 3 18A:64A-9. Appointed members of the board of trustees shall
- 4 be citizens of the United States who have been residents of the
- 5 county appointing them for a period of 4 years prior to said ap-
- 6 pointment. The term of office of appointed members, except for
- 7 the first appointments, shall be for 4 years. Each member shall
- 8 serve until his successor shall have been appointed and qualified.
- 9 Vacancies shall be filled in the same manner as the original
- 10 appointment for the remainder of the unexpired term. Any ap-
- 11 pointed member may be removed by the board of chosen freeholders
- 12 of the appointing county for cause upon notice and opportunity to
- 13 be heard. Members shall serve without compensation but shall be
- 14 entitled to be reimbursed for all reasonable and necessary expenses.
- 15 In the case of a county college established by one county, the
- 16 term of office of members initially appointed to the board of trustees
- 17 shall be as follows: 2 persons shall receive terms of 1 year; 2, terms
- 18 of 2 years; 2, terms of 3 years and 2, terms of 4 years.
- 19 In the case of a county college established by more than one
- 20 county, the chancellor shall fix the terms of the members initially
- 21 appointed to the board of trustees so that as nearly as possible,
- 22 ¼ of the appointed members will receive terms of 4 years, ¼ terms
- 23 of 3 years, ½ terms of 2 years and the remainder terms of 1 year.
- 24 Such terms shall be allocated by the chancellor among the partici-
- 25 pating counties, in accordance with the number of members on the

- 26 board of trustees appointed to each county, starting with the terms
- 27 of 4 years, by allocating one of such terms to each of the partici-
- 28 pating counties in alphabetical order of the names of such counties,
- 29 and continuing, still in such order, with the terms of 3 years, the
- 30 terms of 2 years and the terms of 1 year.
- 31 Members initially appointed to the board may serve from the
- 32 time of their respective appointments, but the term of such office
- 33 shall be deemed to commence as of November 1 of the year in which
- 34 the appointment was made.
- 1 2. This act shall take effect immediately.
