INTRODUCED MARCH 24, 1969

AN ACT concerning motor vehicles and supplementing chapter 5
of Title 39 of the Revised Statutes.

1 BE IT ENACTED *by the Senate and General Assembly of the State*
2 *of New Jersey:*

1 1. Any moving violation of the motor vehicle law which carries
2 with it a penalty of suspension or revocation of a driver's license
3 may, after the effective date of this act, be subject to review by
4 the director. The director, in his discretion, may permit a driver
5 subject to suspension or revocation to elect to attend a Division of
6 Motor Vehicles Driver Improvement School in lieu of all or part
7 of a period of suspension when the violation is a first offense of
8 speeding in excess of 10 miles per hour over the legal limit.

1 2. An accumulation of 12 points within a 3 year period may cause
2 a driver to be subject to a hearing before the Director of the Divi-
3 sion of Motor Vehicles or a hearing officer designated by the
4 director on a rule to show cause why his driver's license should not
5 be suspended, or the driver may elect to attend a Division of Motor
6 Vehicles Driver Improvement School. The director, in his dis-
7 cretion, may permit a driver subject to suspension under this sec-
8 tion to elect to attend a Division of Motor Vehicles Driver Improve-
9 ment School in lieu of all or part of a period of suspension.

1 3. This act shall take effect immediately.

FISCAL NOTE TO

Assembly Bill No. 726 permits attendance at a Division of Motor Vehicles Driver Improvement School in lieu of all or part of the period of suspension of a driver's license.

Based upon costs of operating present Driver Improvement School, for an average of 10,500 students anticipated annually, the Department of Law and Public Safety estimates that enactment of this legislation would require an additional State expenditure of \$146,000.00 in fiscal 1969-70 and \$150,000.00 in fiscal 1970-71. Thereafter, it is anticipated salaries will increase costs by approximately 5%.

In compliance with written request received, there is hereby submitted a fiscal estimate for the above bill, pursuant to P. L. 1962, c. 27.
