

BILL DESCRIPTION

This bill directs the Department of Human Services to issue a monthly supplemental benefit of \$15 to each eligible enrollee of the SNAP, provided that the enrollee is a senior citizen aged 60 years or older or an individual with a disability. This supplemental benefit will be provided with 100 percent State funds, since the federal government sets the average monthly SNAP benefit



amount based on a number of factors, such as household size, and household annual income and resources. The bill appropriates \$20.5 million from the General Fund to the department for this supplemental benefit for eligible SNAP enrollees.

FISCAL ANALYSIS

EXECUTIVE BRANCH

None received.

OFFICE OF LEGISLATIVE SERVICES

The OLS determines that annual State costs under the bill would increase by approximately \$63.8 million in order to provide a State-funded, additional SNAP benefit of \$15 per month for enrollees who are aged 60 and older or who have a disability. Although the federal government funds 100 percent of the standard SNAP benefit, the State is required to provide funding for any supplemental benefits it chooses to provide above the standard benefit. Based on monthly New Jersey SNAP enrollment data in the December 2021 Current Program Statistics report issued by the Department of Human Services, there were 354,180 monthly average SNAP enrollees in 2021 who would qualify for the supplemental benefit provided for under this bill. The OLS notes that SNAP enrollment increased as a result of the COVID-19 pandemic (2021 enrollment was 9 percent higher among those 60 and older or disabled compared to 2019 enrollment levels) and may decline somewhat as the economy improves. However, based on the 2021 enrollment data, the State will spend about \$63.8 million annually to provide the supplemental monthly SNAP benefit. The \$20.5 million appropriated under the bill would fund approximately 47 percent of total costs to the State under the bill. It is important to note that SNAP is an open-ended entitlement program, meaning that any individual who qualifies for SNAP is entitled to receive SNAP benefits. Therefore, the State is obligated to appropriate amounts as are necessary for the supplemental benefit for any individual who qualifies based on age or disability status.

The OLS notes that the federal government funds 50 percent of State administrative costs for the SNAP. As such, any increase in State costs to provide the supplemental benefit via enrollees' existing SNAP electronic benefits card would result in a corresponding increase in State revenues. However, any additional administrative costs and associated revenues are likely to be marginal because the bill provides that the supplemental benefits are to be distributed via the enrollee's existing benefits card on the same date regular benefits are issued.

The Senate Health, Human Services and Senior Citizens Committee reports favorably and with committee amendments Assembly Bill No. 2366.

The committee substitute establishes the State SNAP Minimum Benefit Program in the Division of Family Development in the Department of Human Services (DHS) to ensure that all SNAP households receive a minimum monthly benefit of \$50, and appropriates \$18 million from the General Fund to the DHS to accomplish the goals of the program. SNAP, or the New Jersey Supplemental Nutrition Assistance Program, is a nutrition assistance program that serves as a safety net for low-income households.

Under the program, the division is directed to distribute to each eligible household a monthly State SNAP benefit equal to the difference between the household's federal SNAP monthly benefit and \$50. The State SNAP benefit is to be provided to an eligible household in addition to the federal SNAP benefit. The bill defines eligible household to mean means a household that is certified to receive a federal SNAP benefit of at least one dollar per month, but less than \$50 per month.

The program is subject to the same State rules and procedures for implementing the federal SNAP to the greatest extent possible, including, but not limited to, distributing the State benefit using the program's Electronic Benefit Transfer system and requiring that benefits be used solely for the purchase of food as defined under federal law.

As amended, the bill appropriates \$18 million from the General Fund to the DHS to implement the provisions of the bill.

As reported by the committee with amendments, Assembly Bill No. 2366 is identical to a Senate committee substitute for Senate Bill No. 2156, which was also reported by the committee on this date.

COMMITTEE AMENDMENTS:

The committee amendments remove a section from the bill that would have established a supplemental SNAP benefit of \$15 for senior citizens and eligible individuals with a disability, and replaced it with a section requiring the DHS to establish the State SNAP minimum benefit program, under which each eligible household will be provided a monthly State SNAP benefit equal to the difference between the household's federal monthly SNAP benefit and \$50.

The committee amendments revise the amount of the appropriation under the bill from \$20.5 million to \$18 million.

The committee amendments revise the effective date of the bill from the first day of the fourth month next following enactment to the first day of the sixth month next following enactment.

The committee amendments revise the title and synopsis of the bill to reflect these changes.

Rather, the State would have to bear the full cost each month of providing the difference, if any, between a qualifying household's federal SNAP benefit and \$50.

According to monthly NJ SNAP enrollment data, reported in the April 2022 *Current Program Statistics* report issued by the DHS, 450,365 households received SNAP benefits in that month. In federal fiscal year 2022, the minimum federal SNAP benefit for a household comprised of two persons is \$20 per month; the maximum federal allotment for a household of two persons is \$459 per month, which increases to \$835 per month for a household with four members. For context, data published by the federal government shows that in FY 2020, the average monthly benefit per SNAP-enrolled household in New Jersey was \$314.85. If ten percent of households receiving SNAP benefits in the State receive the minimum federal SNAP benefit of \$20 per month, the bill would increase annual State expenditures by roughly \$16 million to bring these households' monthly SNAP benefits up to the \$50 prescribed in the bill.

The OLS notes that the federal government funds 50 percent of State administrative costs for the SNAP. As such, any increase in State costs to administer the State SNAP Minimum Benefit Program would result in a corresponding increase in State revenues. The bill provides that the State is to distribute this supplemental benefits to eligible households via enrollees' existing benefits card.
