Violators are subject to fines of not less than \$25 or more than \$50.

The Senate Law and Public Safety Committee reports favorably Assembly Bill No. 1709(2R).

This bill requires anyone who operates a vessel on the waters of the State with a child 12 years of age or under on board to see that the child wears a properly fitting personal flotation device (PFD) approved by the United States Coast Guard, unless a device of a size to properly fit the child is not commercially available. Violators are subject to fines of not less than \$25 or more than \$50.

Currently, the State's boating regulations require that every vessel be equipped with a serviceable United States Coast Guard approved PFD for each person on board. These regulations, found at N.J.A.C.13:82-1.4, do not specify that the PFD be worn.

The bill also requires the Boat Regulation Commission to adopt the rules and regulations necessary to effectuate the bill's requirements.

According to the National Recreational Boating Safety Coalition, 32 states currently require children to wear PFDs while on board a vessel. Twenty-one of those states require children aged 12 years and under or children under 12 years old to wear PFDs. The other 11 states mandate the wearing of PFDs for children of varying ages under 12 years.

This bill is identical to Senate Bill No. 1103, which was released by the committee on this same date.

ADOPTED: MARCH 16, 1998

This amendment requires anyone who operates a vessel on the waters of the State with a child 12 years of age or under on board to see that the child wears a properly fitting personal flotation device (PFD) approved by the United States Coast Guard.

As introduced, the bill applied to children 10 years of age or under. The amendment also changes the effective date from immediately to January 1, 1999.
