! While the Office of Legislative Services (OLS) is unable to specify the fiscal impact of this bill, the bill does not require direct expenditure by the State. It is probable that compliance with the bill would require a large expenditure on the part of the Port Authority and the City of New York, New York.

BILL DESCRIPTION

Senate Bill No. 1924 of 2002 requires the Port Authority of New York and New Jersey to remove the ash from the Fresh Kills Landfill on Staten Island, New York and place the ash into containers. The containers are intended to be used as part of a memorial in downtown Manhattan, New York. Over 1.8 million tons of debris from the World Trade Center disaster was transported over the course of 10 months to the Fresh Kills Landfill on Staten Island. Identifiable debris was sorted, and human remains removed for DNA analysis. According to the New York City budget office, 1.2 million tons of unidentifiable ash remain at the landfill, consisting of ash and pulverized granular material (commingled wood, plastic, glass, wallboard, metal fragments and concrete).



FISCAL ANALYSIS

EXECUTIVE BRANCH

OFFICE OF LEGISLATIVE SERVICES

OLS does not have sufficient information to specify the cost of this bill. However, compliance with the bill would require costs to be incurred by the Port Authority of New York and New Jersey, the City of New York, New York, and some Federal agencies. No action or expenditure by the State is directed by the bill. The Port Authority responsibility, according to the bill, is only to recover the ash from the landfill, place it into containers, and transport it to lower Manhattan, New York. In part, this would be a reverse of the process conducted by New York City in the initial removal and transport of material from the World Trade Center site.

According to the Federal Emergency Management Agency (FEMA), FEMA has obligated \$66.7 million to New York to reimburse the Department of Sanitation of New York (DSNY) for the costs of labor and equipment used to transport the debris to the landfill site. Initially, timely transport of 1.8 million tons of debris to the landfill required the dedication of a large fleet, with traffic diversion, for over 10 months. This included over \$15 million for costs associated with transport of debris, and related costs for safety measures for hazardous materials in the debris, barge transfer operations, and leachate control.

According to the New York budget office, the removal of this material from Fresh Kills Landfill would require the approval of both the U.S. Environmental Protection Agency and the New York State Department of Environmental Conservation (NYSDEC), following an assessment by both agencies of the health risks associated with the removal work.

The logistical difficulties of the task pose a challenge to a fiscal estimate. The Port Authority can be expected to incur some significant cost to recover the 1.2 million tons of remaining ash and transport it back into downtown Manhattan, presuming that the E.P.A., the NYSDEC, and the City of New York agree to the transport of the material. Now that the ash has been sifted and large debris removed, replacing it in Manhattan may be simpler, but would still entail significant outlay of resources for such activities as traffic control on the part of New York City in order for the Port Authority to comply with the provisions of the bill.

The Port Authority is also directed to encapsulate the ash in containers. While the cost of the containers is unknown, the amount of ash would involve some expense on the part of the Port Authority, in order to comply with environmental regulations (the ash includes hazardous material).

Finally, as far as OLS is aware, several designs for a potential memorial have been proposed, but not finalized. However, all of those proposals involve a ground level park, with associate engineering flexibility. The physical placement of 1.2 million tons of containerized ash in the smaller footprint of the memorial park could require revision of the architectural and engineering concerns for the area currently established by New York city. The cost of such revisions are presumably to be borne by New York.
